The Association claims a lien upon property owned by **Nancy Cole** situated in Shelby County, Alabama described as follows:

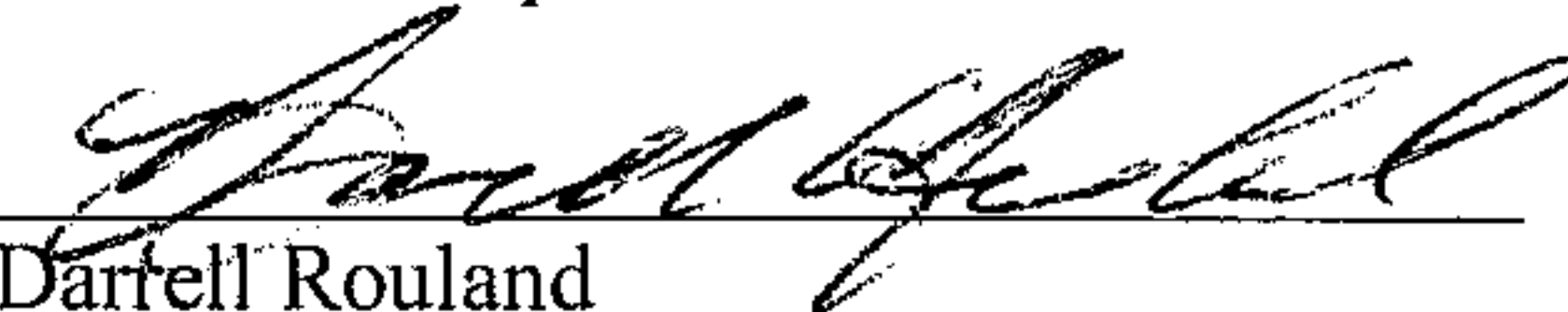
Lot 91, as recorded in Map Book 29, Page 83, Shelby County, Alabama records

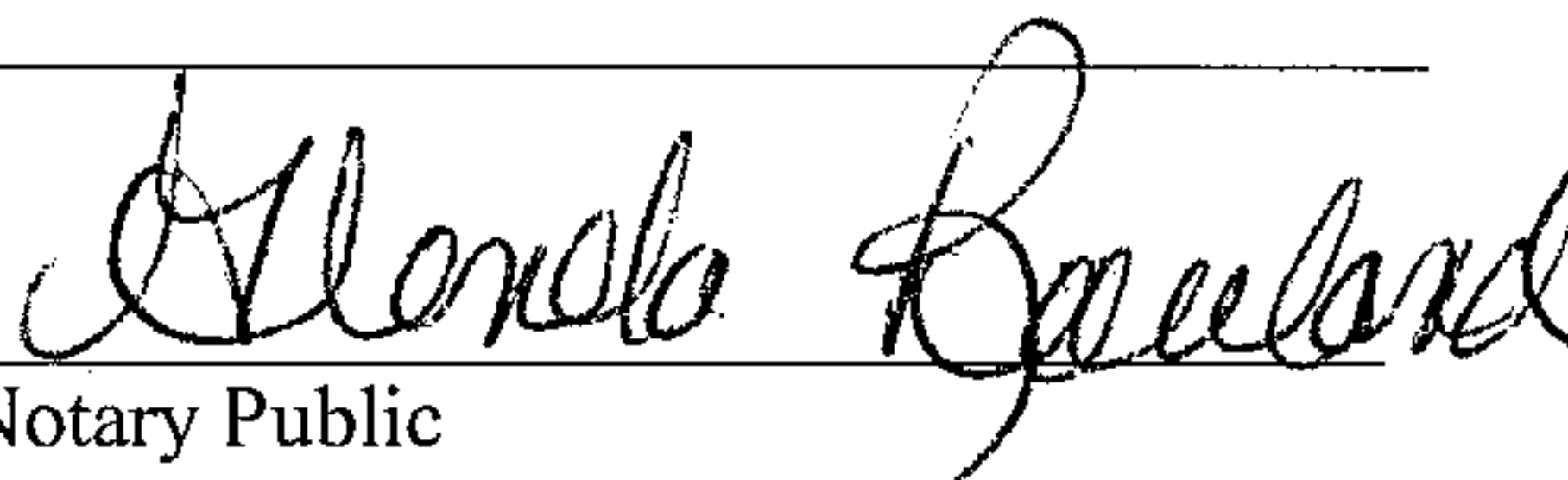
