FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on April 30, 2010, to-wit: Brooke Yonkie, unmarried, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for SouthFirst Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on May 5, 2010, in Instrument No. 20100505000139940, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded February 10, 2015 in Instrument No. 20150210000043420, Probate Records of Shelby County, Alabama; and



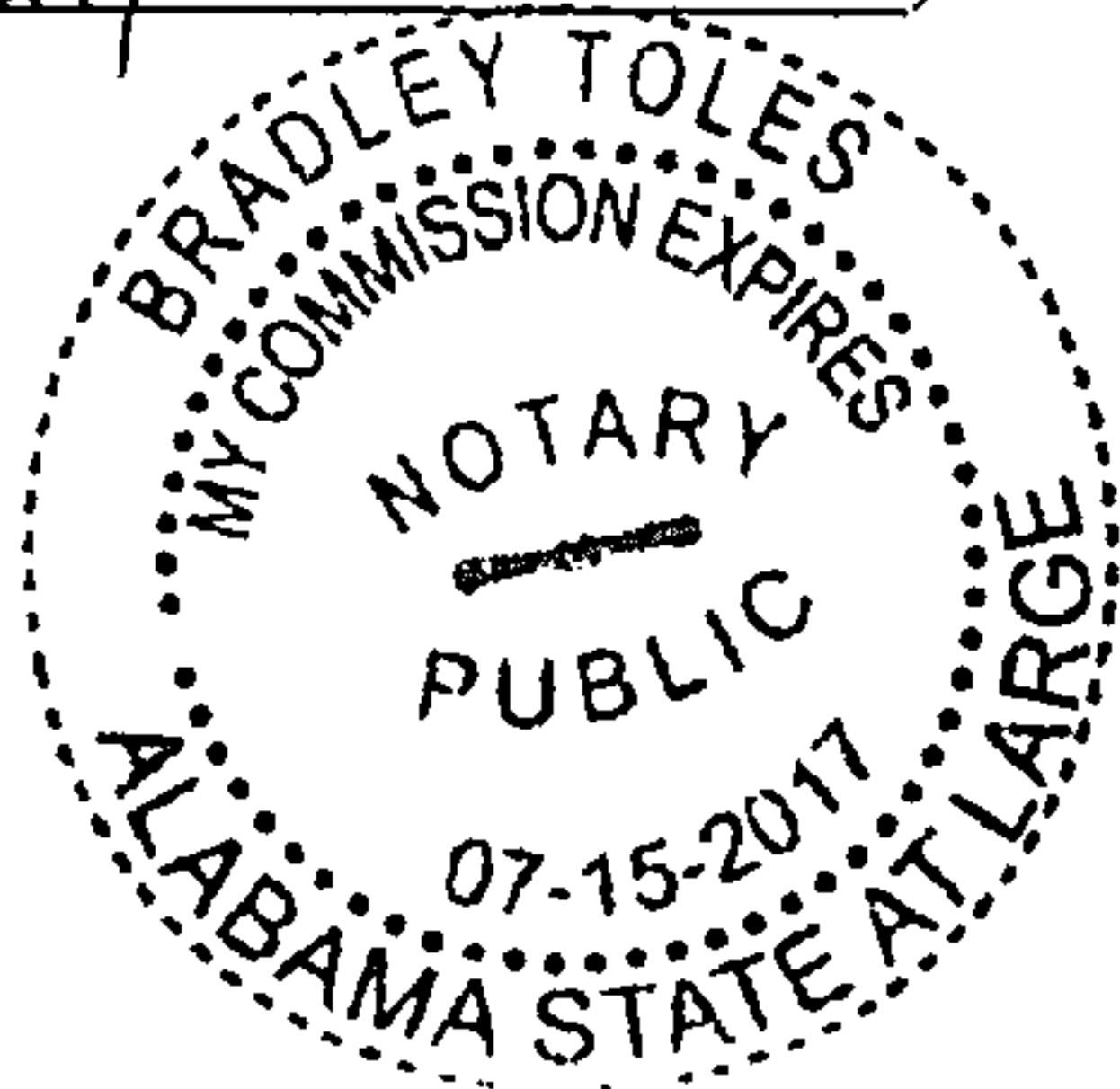


