WITNESSETH:

WHEREAS, under the terms, conditions, covenants, and provisions set forth in that certain Mineral Lease Agreement dated and effective December 31, 2015 (the "Effective Date"), executed by and between Alabama Property Company, an Alabama corporation ("APC"), and Lessee (the "Lease"), as amended by that certain Agreement Regarding Mineral Lease Agreement dated October 20, 2016, by and between Lessor, Lessee, and APC, to correct and amend the Lease to substitute Lessor for APC as the lessor under the Lease, Lessor has leased to Lessee certain of Lessor's interest in and to that certain parcel of Lessor's lands in Shelby County, Alabama, as depicted on the maps attached as Exhibit "A" and Exhibit "B" and made a part hereof (the "Premises"), for surface and highwall coal mining purposes as therein set out.

TO HAVE AND TO HOLD, the leased land for a term of five (5) years which may, upon mutual agreement of the parties, be renewed for one (1) additional three (3) year term. Lessee shall have the right after the termination of the Lease for any reason to re-enter the Premises for the purpose of reclaiming areas disturbed by Lessee's mining operations and otherwise complying with requirements of any federal, state, or local law, rule, regulation or ordinance, and Lessee shall have the right to remove from the Premises within three (3) months after said expiration or termination, all of Lessee's surface and underground equipment, facilities, supplies and materials from the Premises. Said Lease and all of the terms, conditions, covenants and provisions thereof being by this reference incorporated herein and made a part hereof in all respects as though fully set forth herein and reference being hereby made to one (1) fully executed copy of the Lease in the possession of Lessor and Lessee for the full particulars thereof.

It is not intended by this Memorandum to construe, define, limit or modify the Lease, but merely to disclose to the public the existence of the Lease.

This Memorandum may be executed in multiple counterparts, each of which shall be deemed to constitute a single agreement. For recording purposes, the executed counterparts shall be combined into a single instrument.
