
The undersigned, Terry Colafrancesco as President and Joan McDonald as Secretary of Abode of God, a non profit corporation organized and existing under the laws of the State of Alabama, hereby certify that, in accordance with Ala. Code § 10A-3-7.01 (1975), a Statement of Intent to Dissolve the Corporation was duly filed in the Office of the Judge of Probate of Shelby County, Alabama, and in connection therewith we do make the following further statements:


1. The name of the Corporation is Abode of God.
2. A Statement of Intent to Dissolve the Corporation was filed on the 16th day of MAY, 2017, in the Office of the Judge of Probate of Shelby County, Alabama.
3. That all known debts, obligations and liabilities of the Corporation have been paid and discharged, or adequate provision has been made therefor.
4. The following Plan of Distribution was adopted by the Corporation:

After providing for all proper debts of the Corporation, the remaining assets of the Corporation shall be distributed to Caritas of Birmingham which is a charitable organization that qualifies under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations.
5. That pursuant to Article IV of the Articles of Incorporation of the Corporation and in accordance with the provisions of Ala. Code § 10A-3-1, et al., all of the remaining property and assets of the Corporation have been distributed exclusively to charitable, religious, scientific, literary or educational organizations qualifying under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations.
6. That there are no suits pending against the Corporation in any court.

We further certify that the within Articles of Dissolution are being filed in the Office of the Judge of Probate of Shelby County, Alabama, for the purpose of effecting such dissolution in accordance with the requirements of Ala. Code § 10A-3-7.06 (1975).



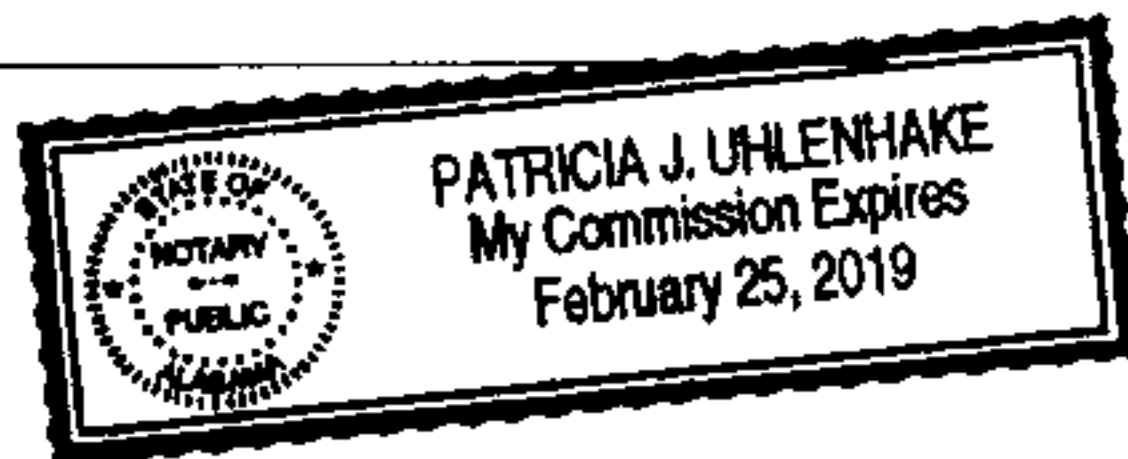
