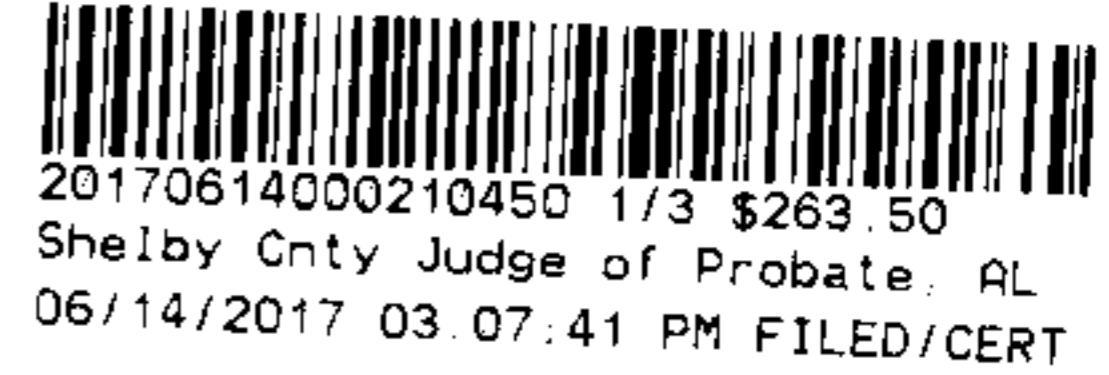

WARRANTY DEED

**STATE OF ALABAMA

KNOW ALL MEN BY THESE PRESENTS,

On this June 9, 2017, That for and in consideration of **TWO HUNDRED FORTY TWO THOUSAND FIVE HUNDRED AND NO/100 (\$242,500.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **THE LANHAM FAMILY LIVING TRUST, by Randee C. Lanham and Rebecca Helen Lanham as Co-Trustees**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **MARK L. BRICKEY and HOWARD WINSTON and ASHLEY WARE**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:
