Know All Men by These Presents: That in consideration of **One Hundred Eighty-Seven Thousand Five Hundred Ten and no/100 Dollars (\$187,510.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor), does hereby grant, bargain, sell and convey unto **JEREMY S. CURRIE and MEREDITH K. CURRIE** (herein referred to as Grantees), the following described real estate, situated in **Shelby** County, Alabama, to-wit:


