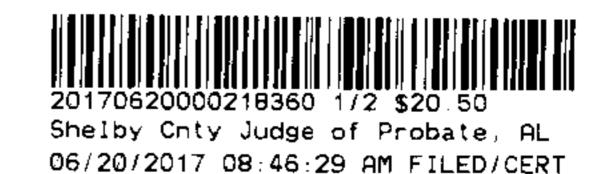
## WARRANTY DEED
