KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two-hundred seventy-six thousand (\$276,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Cindy Wingate, formerly known as Cindy E. Stewart, and husband, Frederick O. Wingate (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Matthew Hillman and Alecia Hillman (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 411, according to the Survey of Lake Forest, Sector 4, as recorded in Map Book 28, Page 93, in the Office of the Judge of Probate of Shelby County, Alabama.


