**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of Three-hundred fifty-six thousand fourteen (\$356,014.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Building Bama, Inc., an Alabama Corporation (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Janet Hudson Bell and Ronald Park Bell (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 821, according to the Survey of Grande View Estates, Givianpour Addition to Alabaster, 8th Addition, as recorded in Map Book 32, Page 47, in the Probate Office of Shelby County Alabama.
