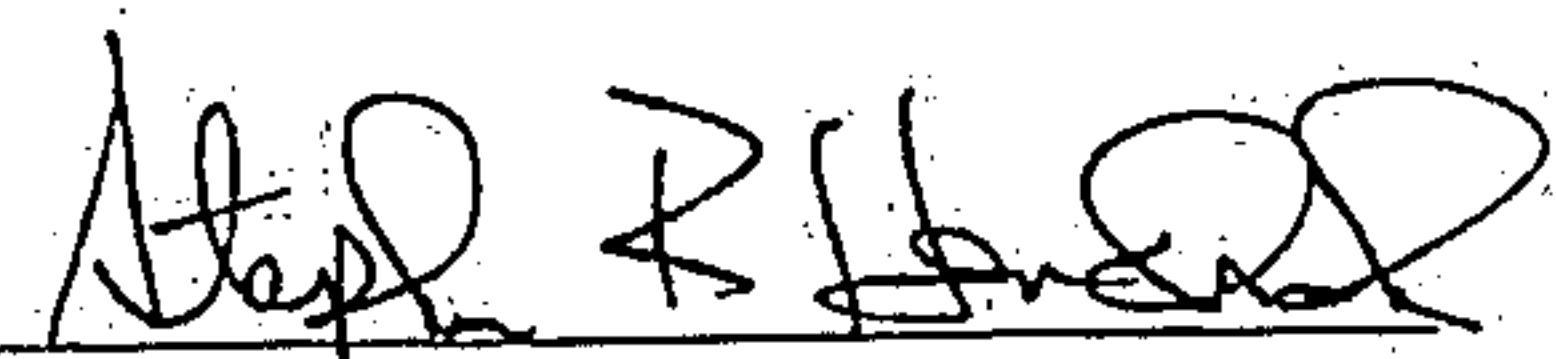
Certificate of Trust Hendricks Living Trust dated May 30, 1997

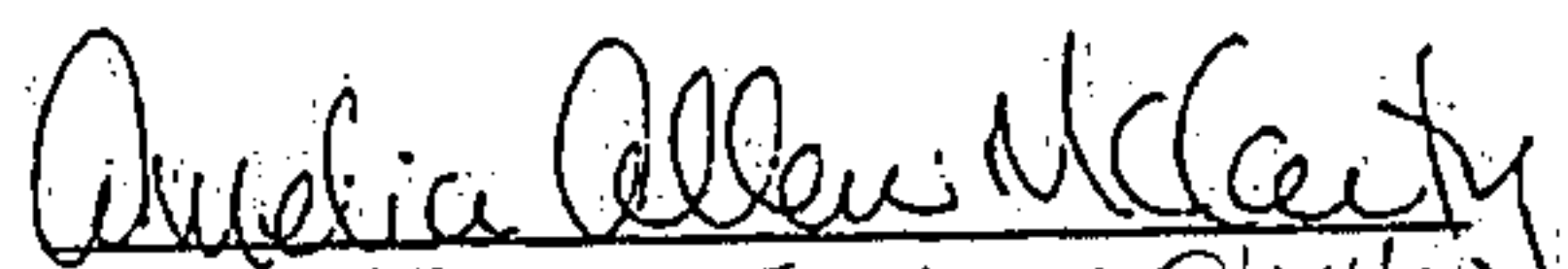

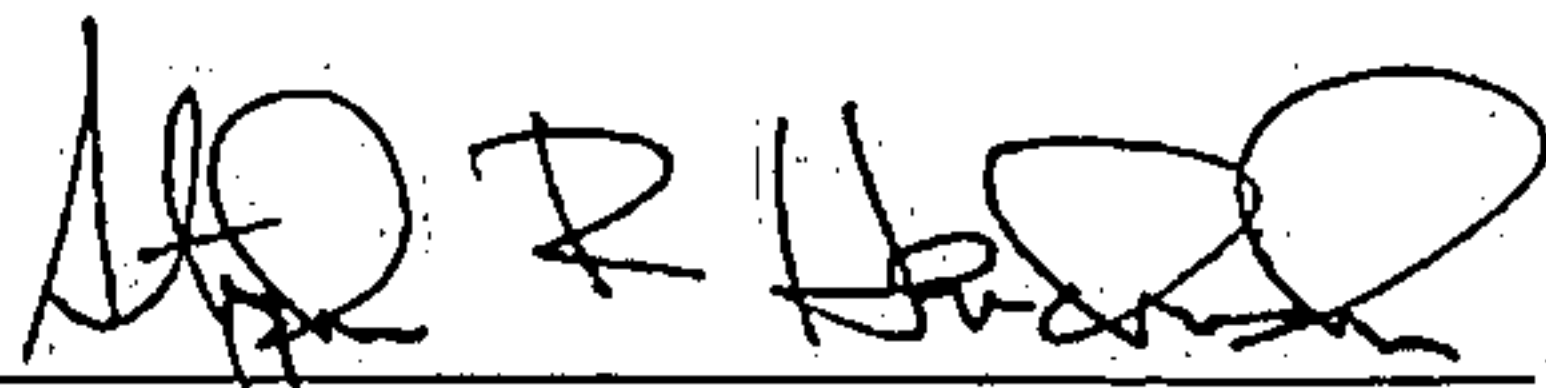
