KNOW ALL MEN BY THESE PRESENTS, That in consideration **FORTY NINE THOUSAND TWO HUNDRED FORTY FIVE AND NO/100'S DOLLARS (\$49,245.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Melanie Denise Herring and husband, James Ralph Herring and Samantha Lea Herring a single woman** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **James Ralph Herring and Samantha Lea Herring**, (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:
