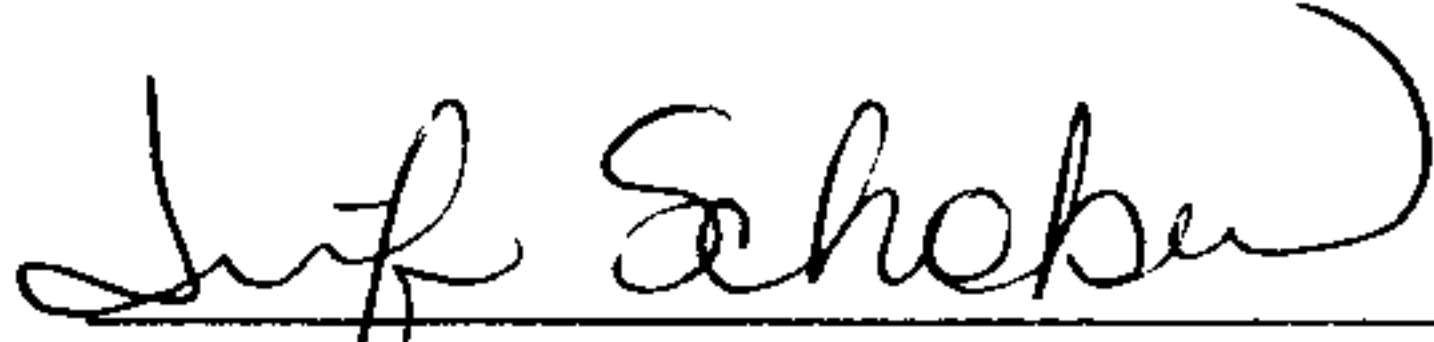
8. **Dissociation of Members.** The dissociation of one or more members for any reason shall not cause the dissolution of the Company.
