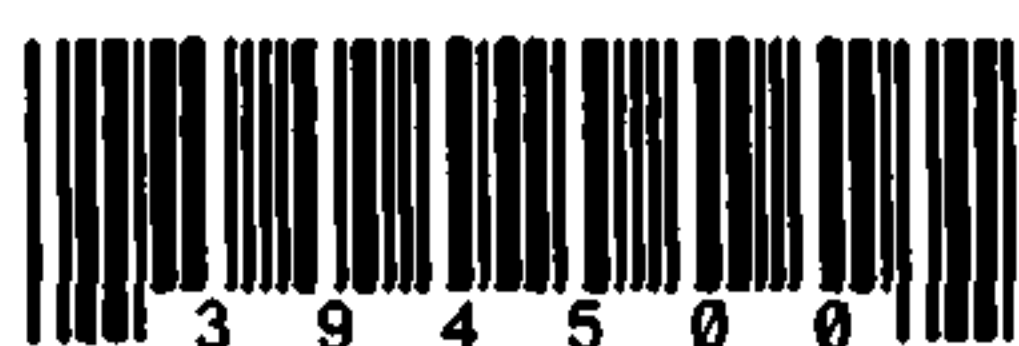
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of April, 2007, David A. Miller, a married man, and Monica Miller, a married woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Bluestar Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070430000199250, said mortgage having subsequently been transferred and assigned to Citibank, N.A., as trustee for CMLTI Asset Trust, by instrument recorded in Instrument Number 20161104000407250, in the aforesaid Probate Office ("Transferee"); and

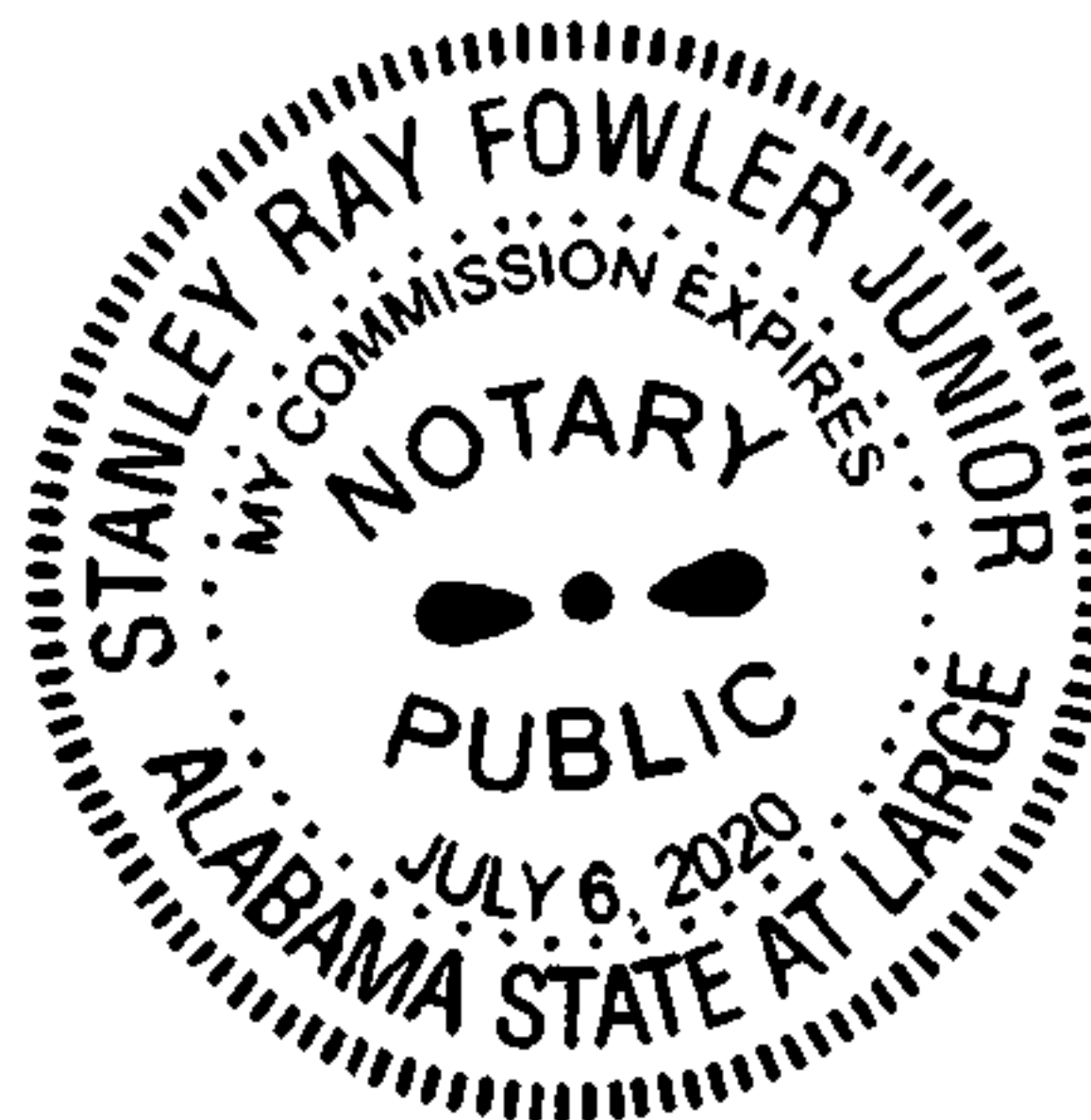

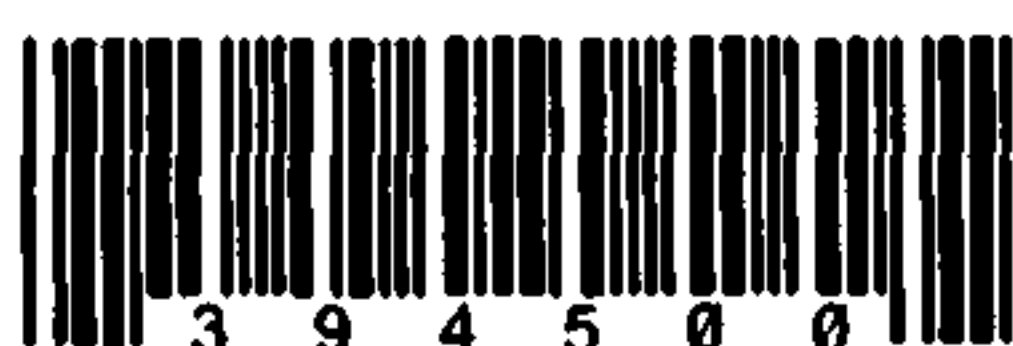
