The Association claims a lien upon property owned by **Steven Daniel Thomas**, situated in Shelby County, Alabama described as follows:

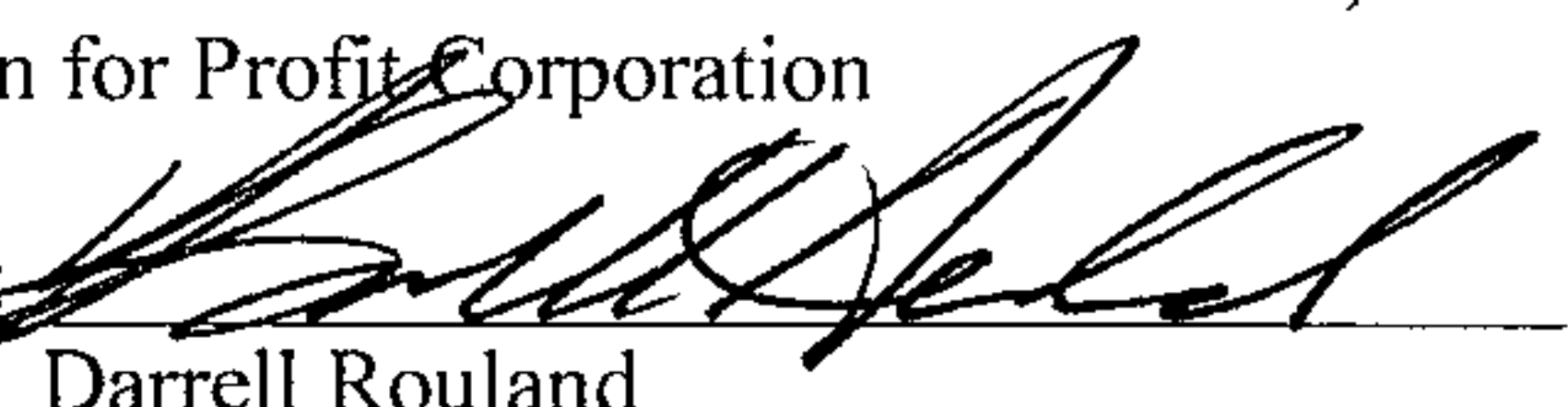

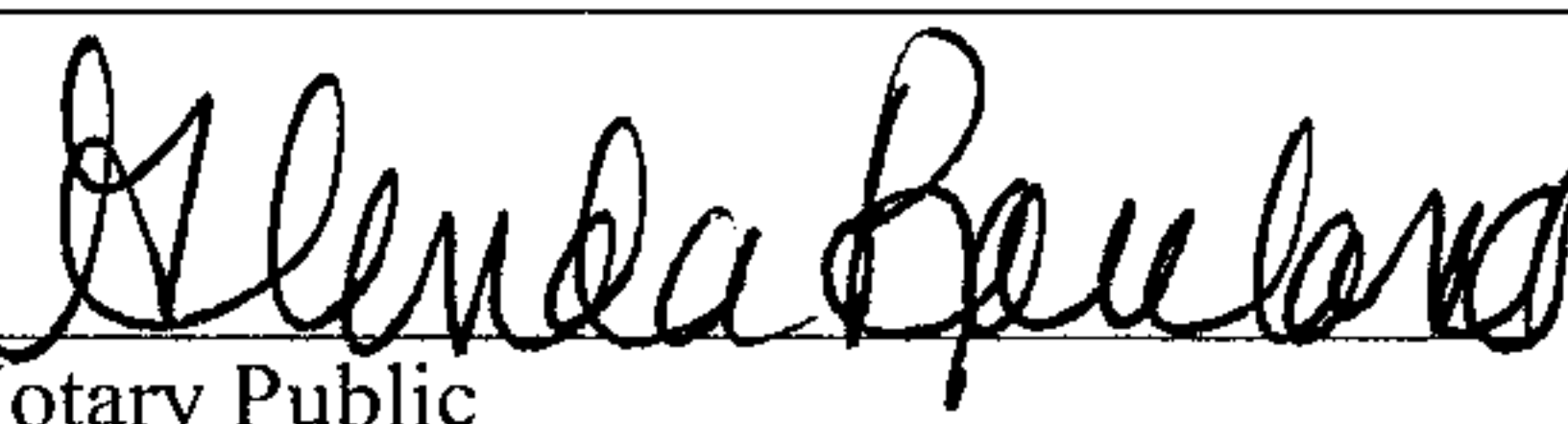

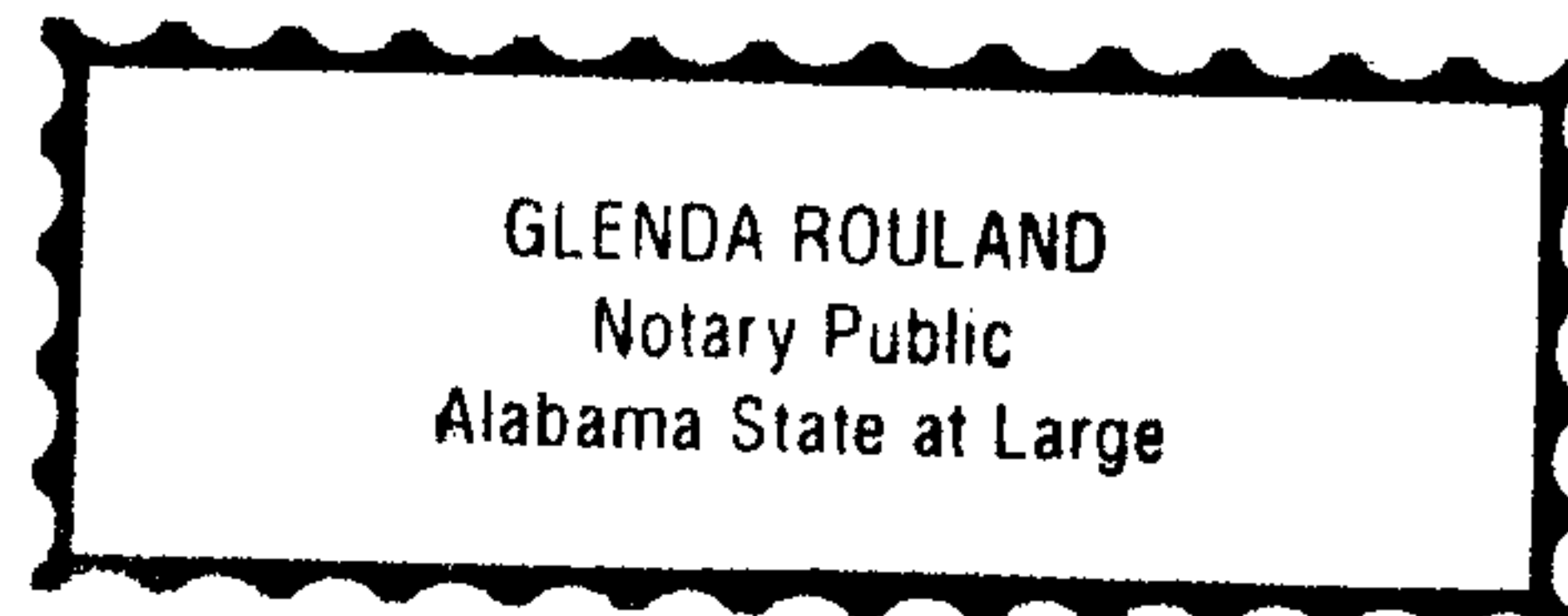
