Lot 77, as recorded in Map Book 31, Page 125 A-B, Shelby County, Alabama records

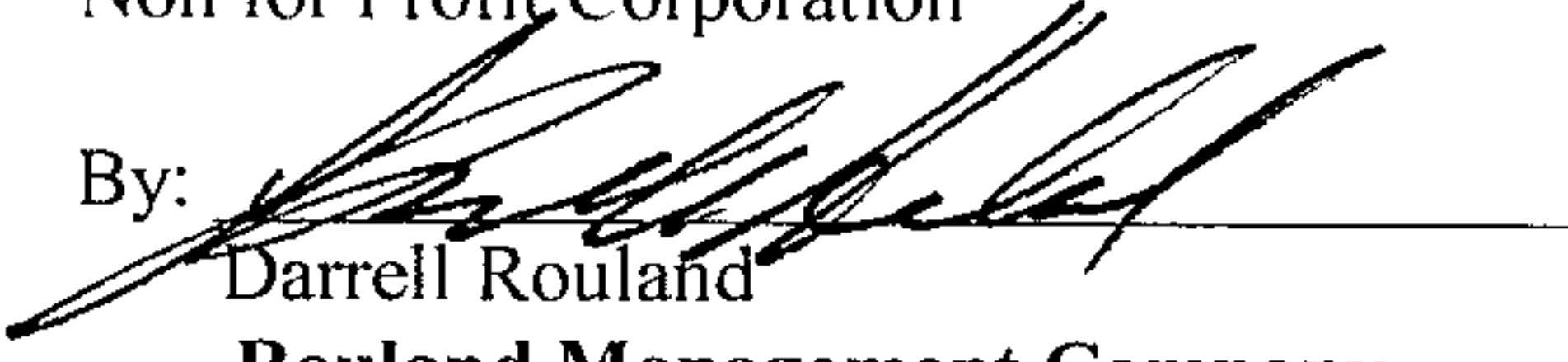

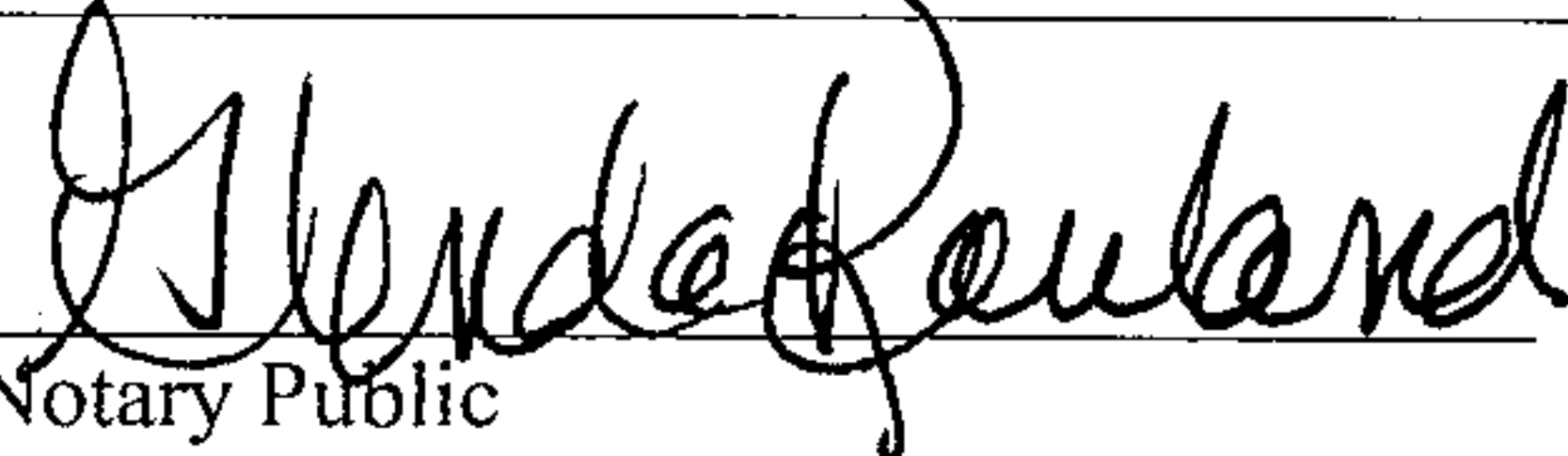
