**WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Four Hundred Fifty-Two Thousand and 00/100 Dollars (\$452,000.00) **the amount which can be verified in the Sales Contract between the two parties** in hand paid to the undersigned, JERI L. EVANS, a single individual **whose mailing address** is: 20103 Retreat Lane Birmingham, AL 35242 (hereinafter referred to as "Grantors") by JEROME ALAN SPEEGLE and BESS M. SPEEGLE **whose property address** is: 204 SHEFFIELD LN, BIRMINGHAM, AL, 35242 hereinafter referred to as Grantees"), the receipt and sufficiency of which are hereby acknowledged, Grantor does, by these presents, grant, bargain, sell, and convey unto Grantees, as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

3. Public utility easements as shown on recorded plat, including any tree bufferline as shown on recorded plat.




