KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of December, 2010, Robert M. Armstrong and wife, Linda J. 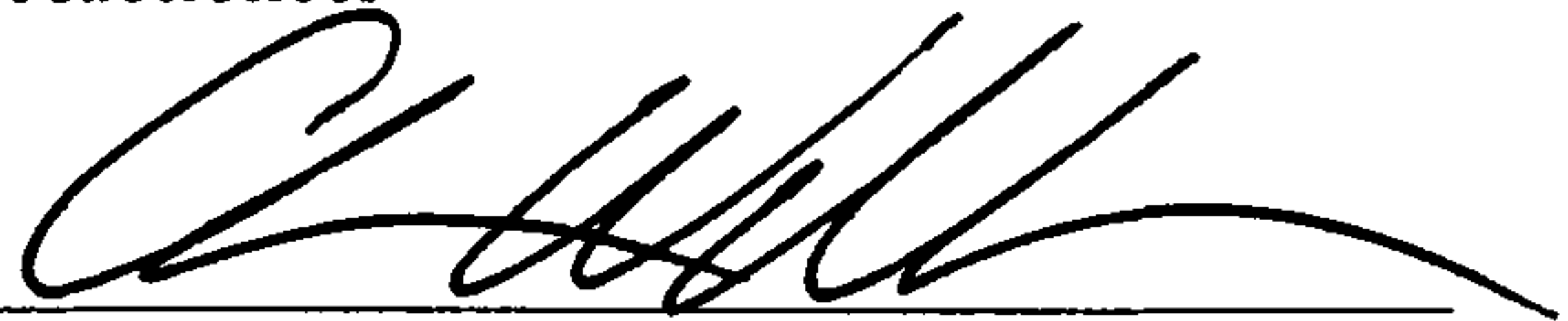

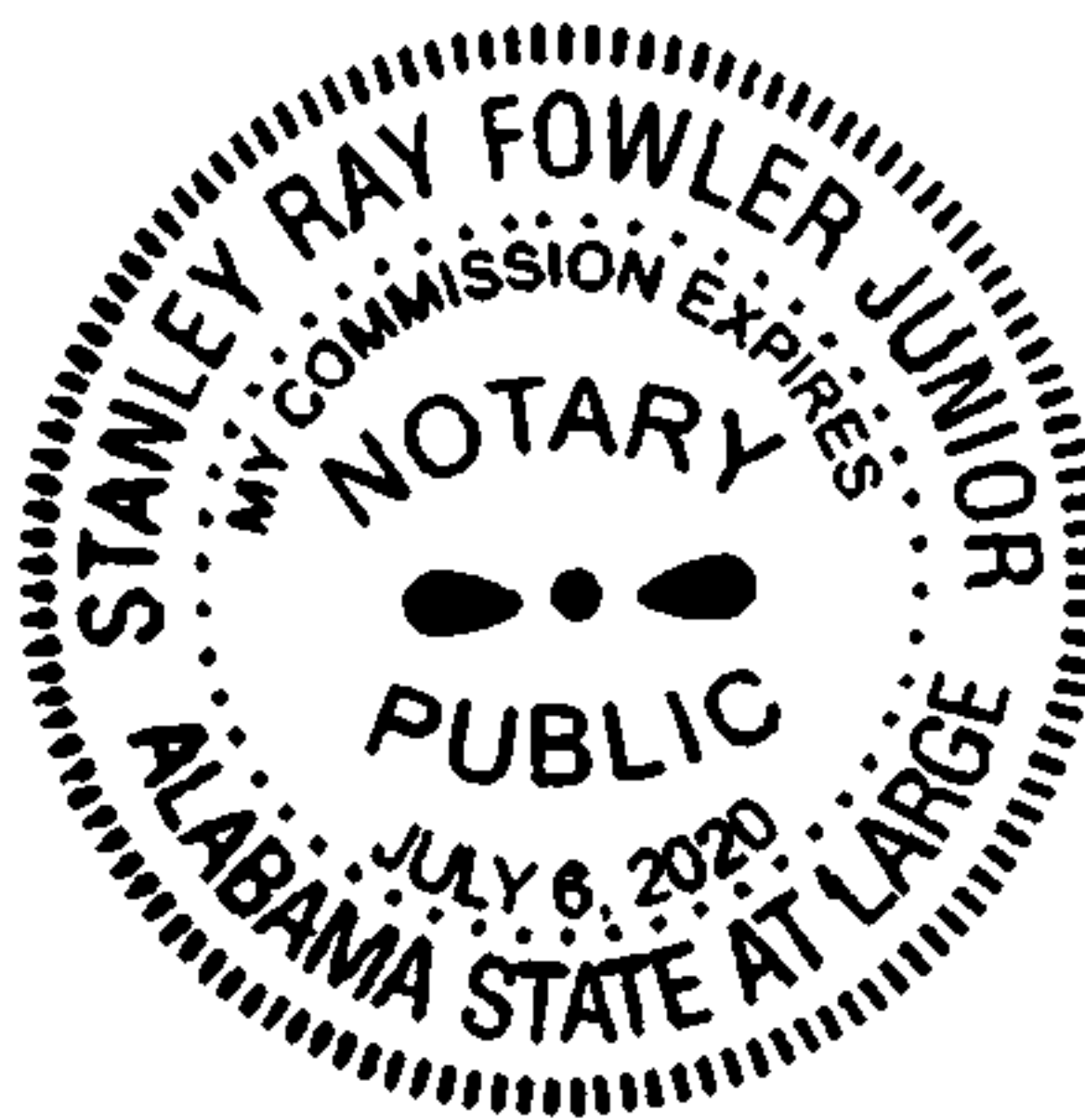

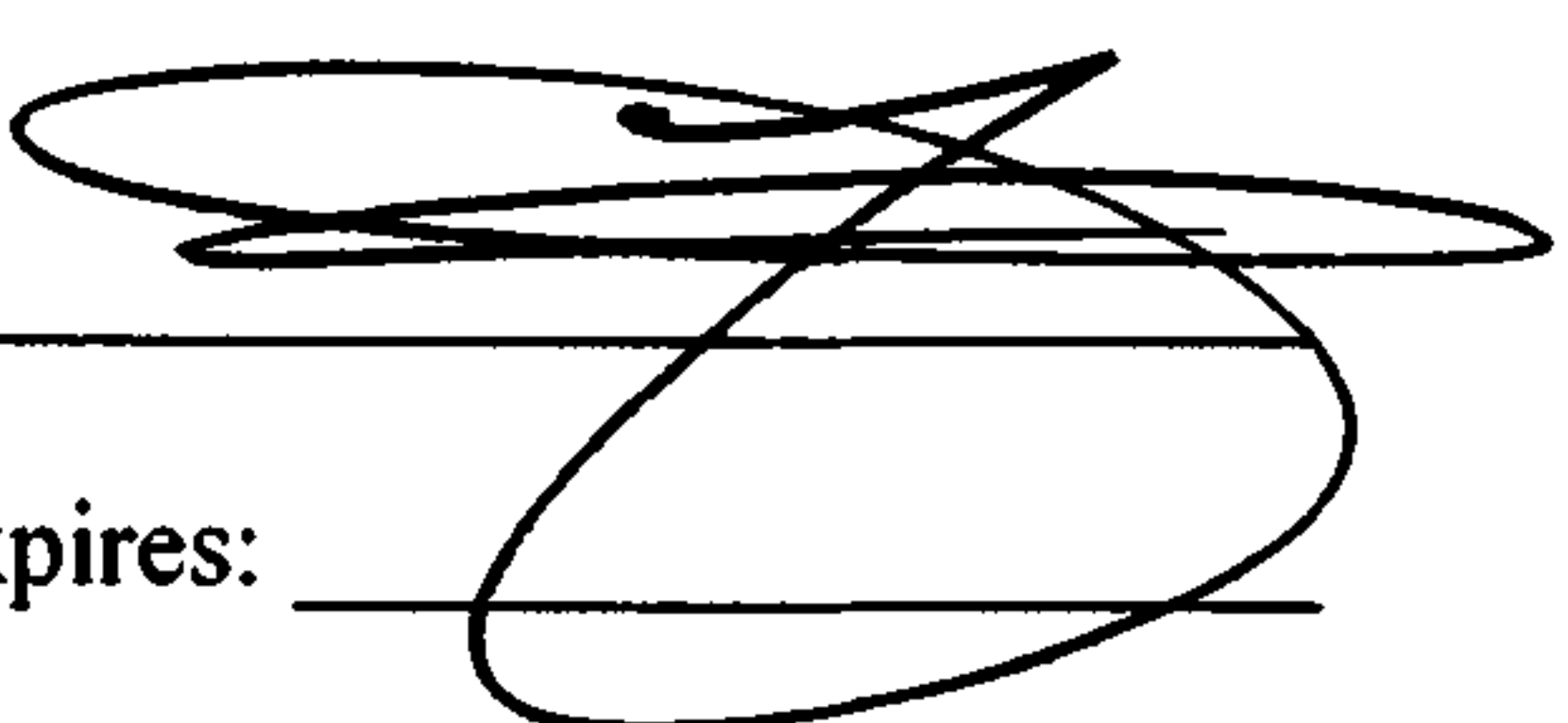
