
SUBJECT TO:

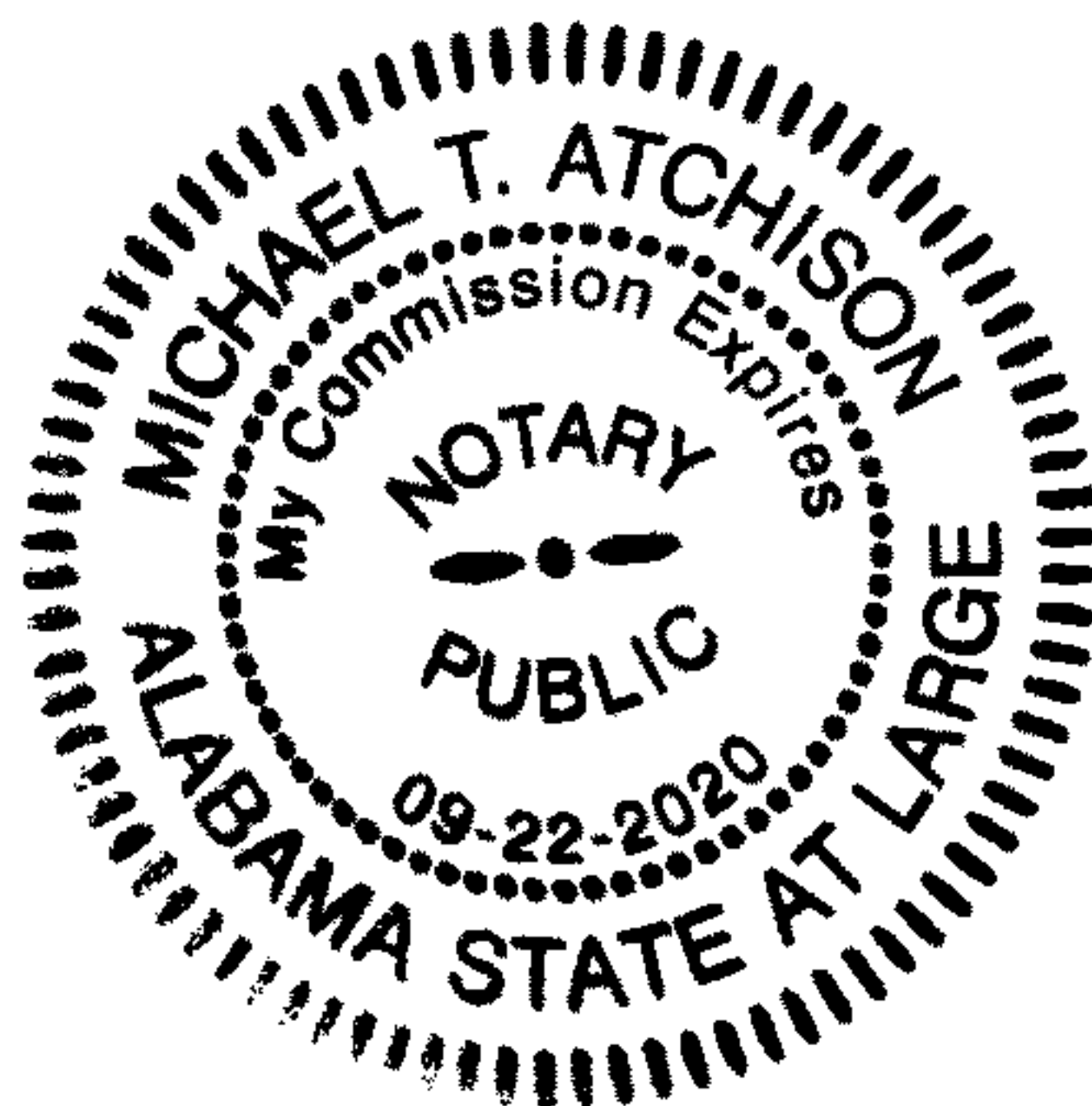
