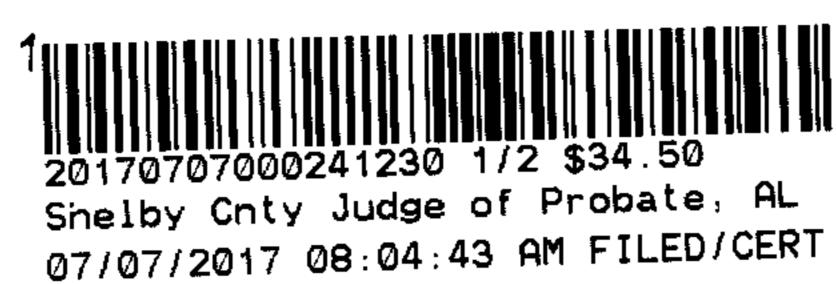

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Three Hundred Twenty-Two Thousand Six Hundred Twenty-Five and 00/100 (\$322,625.00), and other good and valuable consideration, this day in hand paid to the undersigned Cornerstone Building, LLC, an Alabama limited liability company (hereinafter referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, William M. Humphrey and Mistie C. Humphrey, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 16, according to the Survey of Chelsea Ridge Estates, 1st Sector, as recorded in Map Book 35, Page 150, in the Probate Office of Shelby County, Alabama.

Subject To:

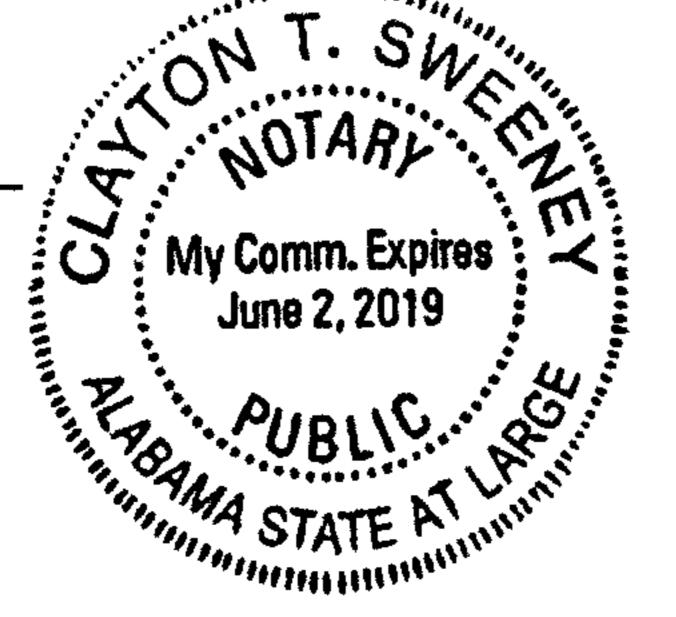
