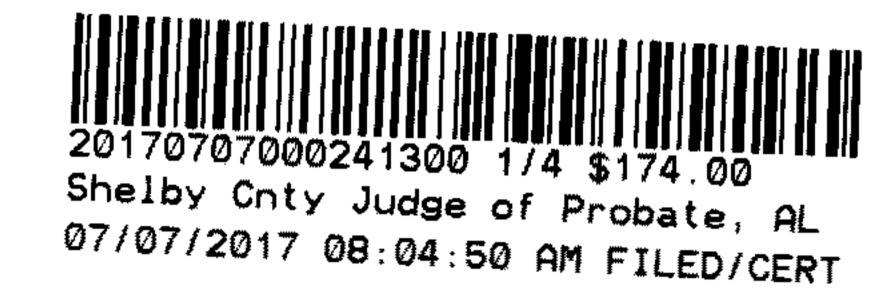

STATUTORY WARRANTY DEED

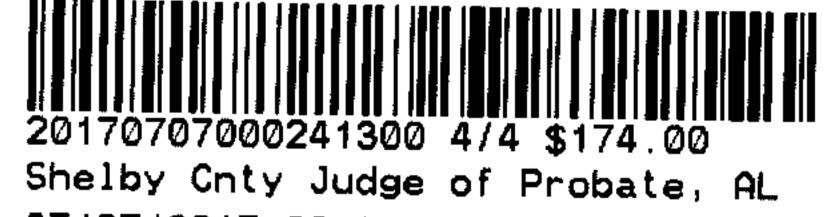
