## WARRANTY DEED

**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of the sum of One-hundred sixty-two thousand (\$162,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Christopher Lampley and wife, Maria C. Lampley (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Amber Noel Boyd and Broderick Robertson (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.
