Pursuant to the Alabama Limited Liability Company Law 2014 as set forth in Chapter 1 and Chapter 5A of the Alabama Business and Nonprofit Entity Code, the undersigned hereby adopts the following Certificate of Formation:

NAME

The name of the limited liability company is Environmental Training Company, LLC (the "Company").

TYPE

The Company is a limited liability company.

DURATION

The Company shall have perpetual duration unless it is dissolved and its affairs wound up in accordance with the Alabama Business and Nonprofit Entity Code or the Operating Agreement of the Company.

PURPOSES

The purposes for which the Company is formed are:

To provide educational training, instructions and services for environmental matters; and

To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, industrial engineering, accounting, bookkeeping, management and other services of every nature, kind and character, which it may legally render;

Interest in the Company is nontransferable except as specifically set forth in the Company's LLC Agreement.

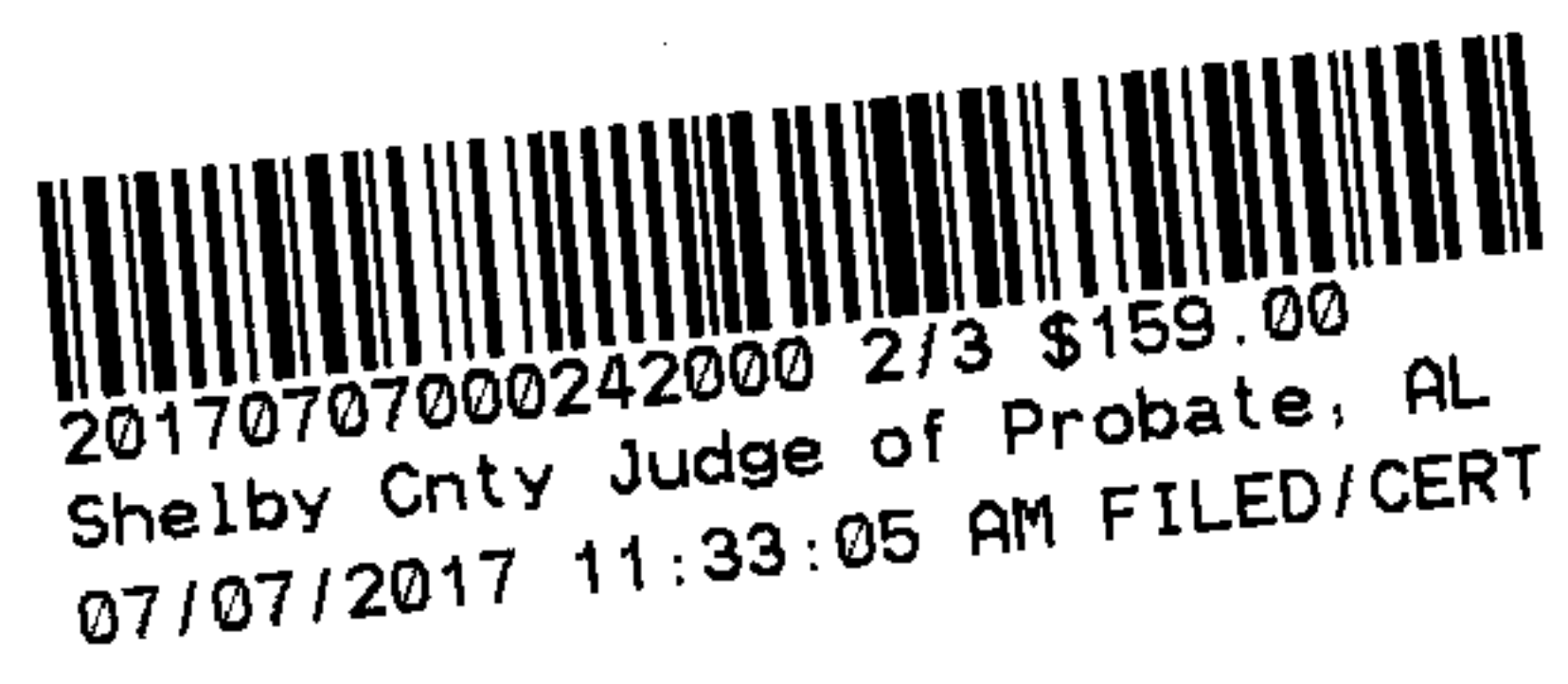
DISSOLUTION BY REASON OF CESSATION OF MEMBERSHIP
