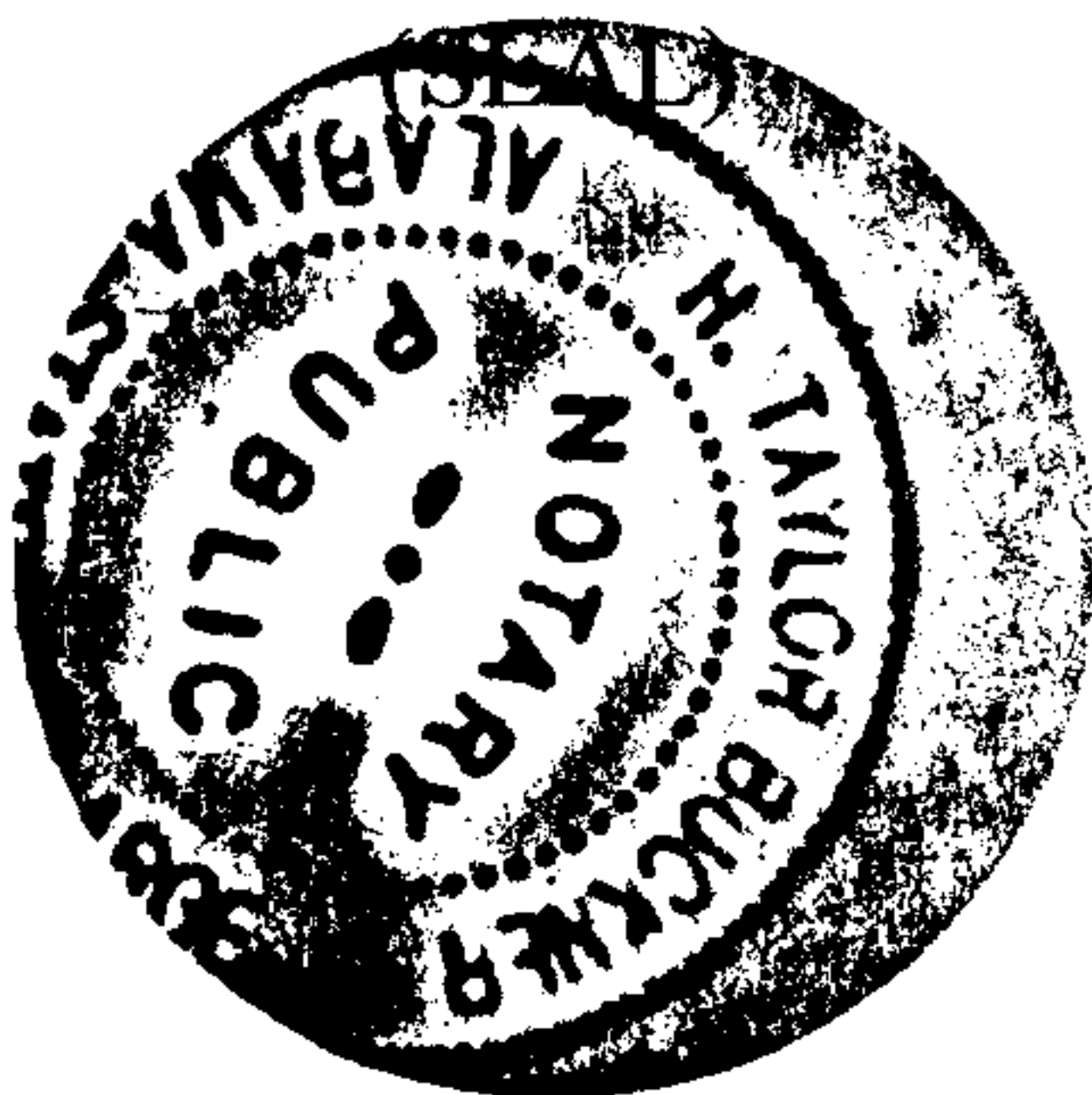

**CONSENT TO DISSOLVE**






