

**ARTICLES OF ORGANIZATION
OF
BERTOLONE HOLDINGS, LLC**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Alabama Limited Liability Company Law, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Bertolone Holdings, LLC

SECOND: The term of the Limited Liability Company shall commence on July 10, 2017 rather than the date of this filing. The term of existence of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is sooner terminated by the occurrence of an event set forth in the Operating Agreement.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Alabama Limited Liability Company Law, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Alabama is 148 Moores Spring Road, Montevallo, Alabama 35115, and the name of the initial registered agent of the Limited Liability Company to whom process may be sent in Alabama at that address is Sonia Bertolone Carrillo.

FIFTH: The principal office of the Limited Liability Company is 148 Moores Spring Road, Montevallo, Alabama 35115.

SIXTH: The Limited Liability Company is to be managed by the Managing Members. The names and addresses of the initial Managing Members are: Sonia Bertolone Carrillo, Mary Carroll and Michael Bertolone. The foregoing Managing Members shall serve as Managing Members until the first annual meeting of the Members or until their successors are duly appointed.

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Members is \$1,002.00. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests, as set forth in the Operating Agreement.

EIGHTH: Additional capital contributions may be made at such times and in such amounts as may be hereafter agreed by the unanimous vote of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company. No additional capital contributions have been agreed to by the Members at this time.

NINTH: The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Managing Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

TENTH: The remaining Members of the Limited Liability Company, by the affirmative vote or consent of Members holding a majority of the Members' Percentage Interests (other than the Managing Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

ELEVENTH: The names and addresses of the Members and Organizers of the Limited Liability Company are: Sonia Bertolone Carrillo having an address at 148 Moores Spring Road, Montevallo, Alabama 35115. Mary Carroll having an address at 116 Moores Spring Road, Montevallo, Alabama 35115 and Michael Bertolone having an address at 116 Ammersee Lakes Drive, Montevallo, Alabama 35115 (collectively hereinafter referred to as "Managing Members").

TWELFTH: At the date of filing of these Articles of Organization, the Limited Liability Company has three Managing Members.

THIRTEENTH: The Limited Liability Company does not have the power to expel a Member.

FOURTEENTH: The Members or parties to a contribution agreement or a contribution allowance agreement have preemptive rights.

FIFTEENTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.



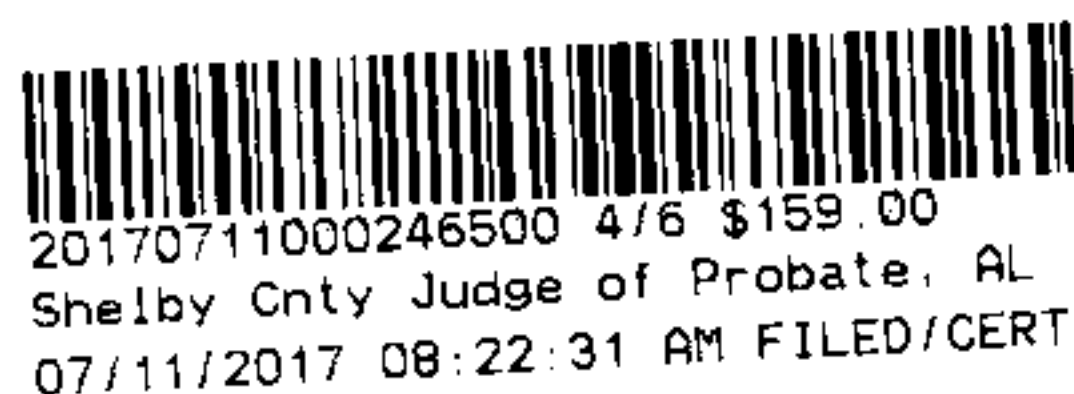

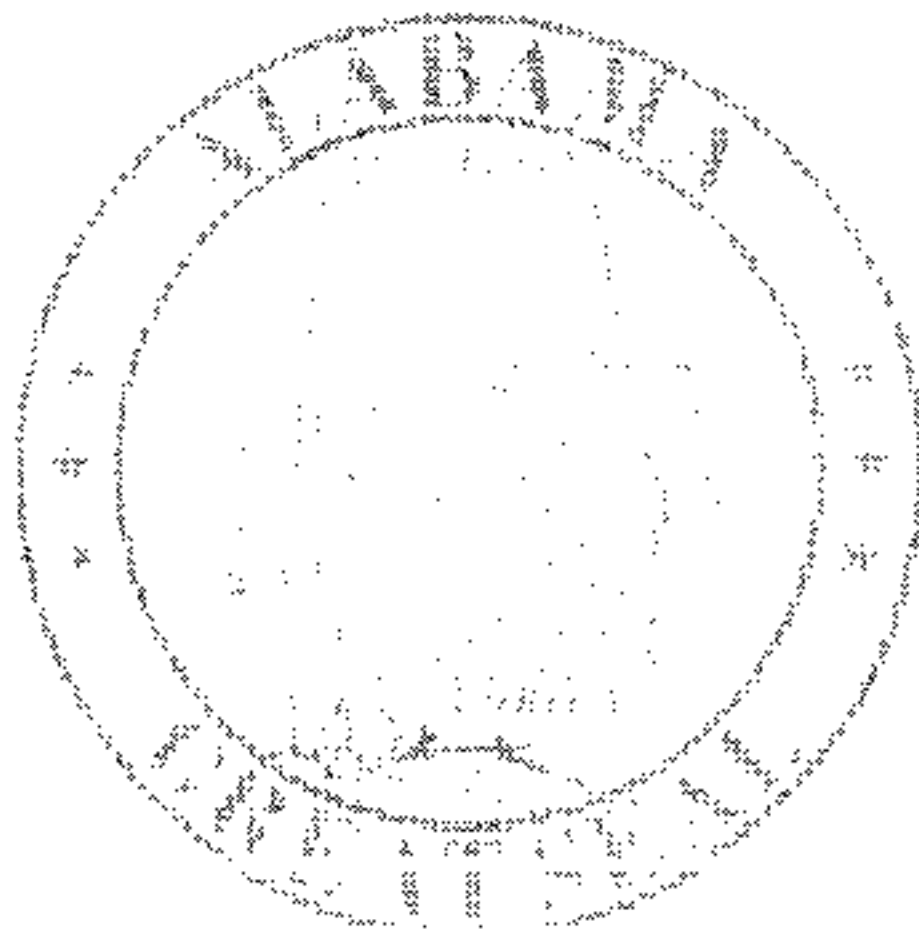
