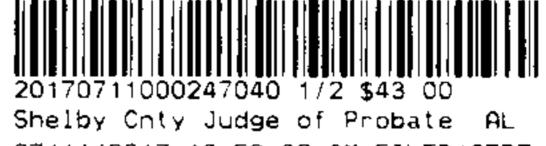

## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

## KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Ten Dollars (\$10.00) and other good and valuable consideration to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, I, Kathey Neely Hairston, (herein referred to as grantors) do grant, bargain, sell and convey unto Kathey Neely Hairston and David Lee Hairston, as joint tenants, with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:
