INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

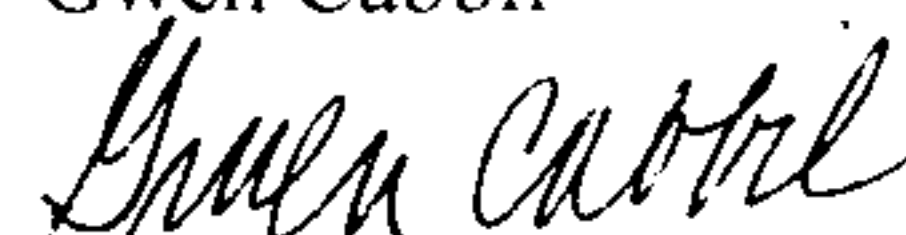

If there is no provision in the Limited Liability Company Agreement of the Company governing the admission of additional members, additional members may be admitted with the written consent of all members at such times and upon such terms and conditions as may be mutually agreed upon by the members and the person desiring to become a member.

**ARTICLE EIGHT
CONTINUATION OF THE BUSINESS**

In the event there are no remaining members, and except as otherwise provided in the limited liability company agreement, if any, the limited liability company shall be dissolved and its affairs shall be wound up unless:

- (a) the holders of all of the financial rights in the limited liability company agree in writing within ninety (90)

days after the cessation of membership of the last member, to continue the legal existence and business of the limited liability company and to appoint one or more new members; or

(b) The legal existence and business of the limited liability company is continued and one or more new members are appointed in the manner stated in an the agreement of the limited liability company.

ARTICLE NINE MANAGEMENT

The management of the Company is vested in its members. Subject to any provisions in the limited liability company agreement of the limited liability company, or the provisions of the Alabama Limited Liability Company Law of 2014 restricting or enlarging the management rights and duties of any person or group or class of persons, the members shall have the right and authority to manage the business or affairs of the limited liability company and to make all decisions with respect thereto.

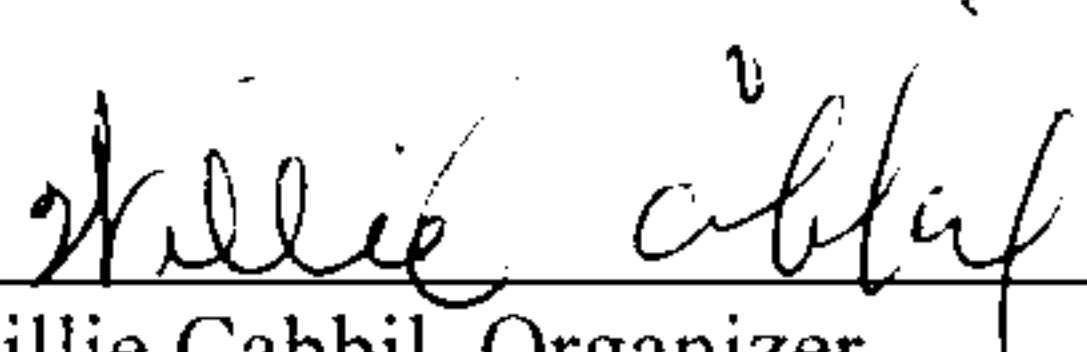
ARTICLE TEN AMENDMENT OF CERTIFICATE OF FORMATION

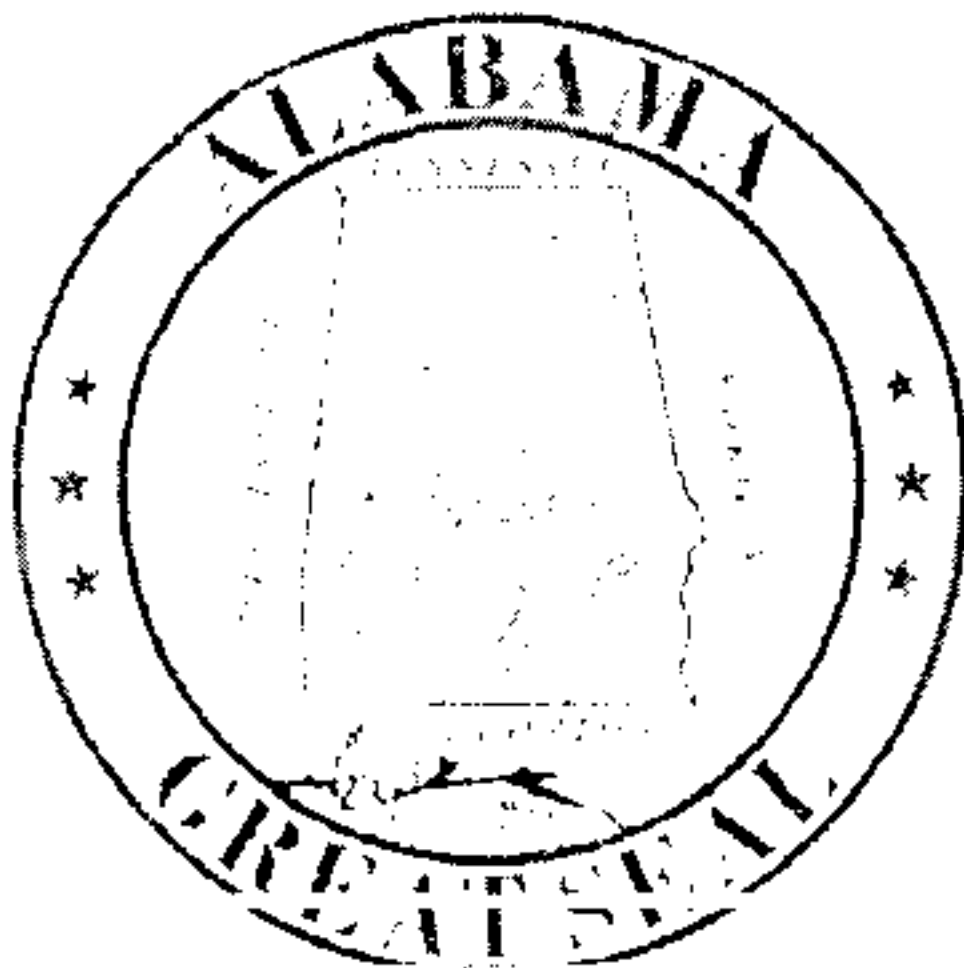
