Know All Men by These Presents: That in consideration of **One Hundred Sixteen Thousand Three Hundred and no/100 Dollars (\$116,300.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **TONI J. TERRY, an unmarried woman** (herein referred to as Grantor), grant, bargain, sell and convey unto **CHRISTOPHER K. CATO and TRACY L. 
