**GENERAL WARRANTY DEED

Varden, a single person**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Jared M. Havens and Amanda Havens** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:


Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.



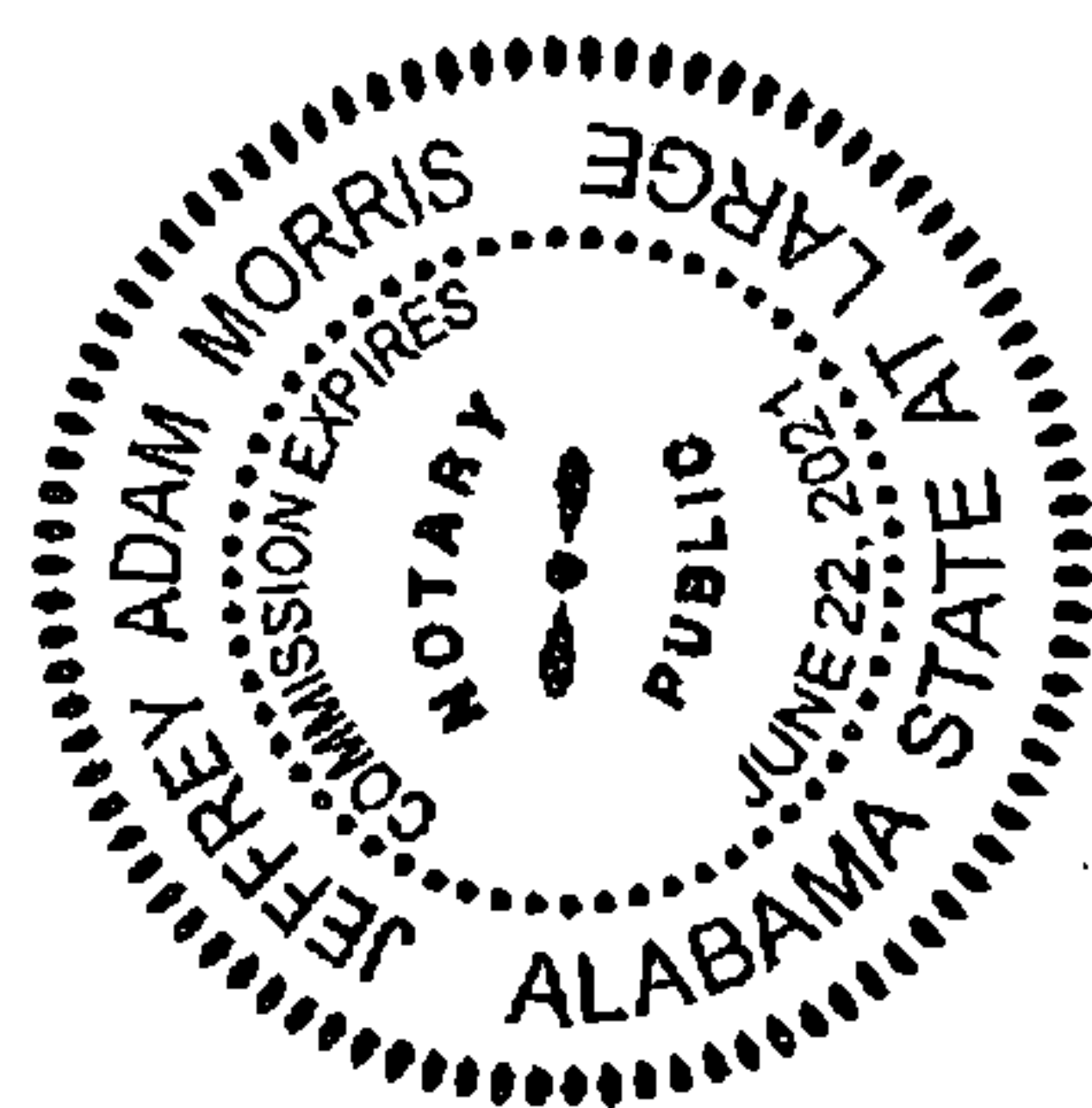
