
ARTICLES OF INCORPORATION/ CERTIFICATE OF FORMATION OF

THE UNDERSIGNED, acting as Incorporator of a Corporation pursuant to the Alabama Business Corporation Act under Section 10A-1-3.05 and 10A-2-2.02 of the Code of Alabama 1975, adopts the following Articles of Incorporation (also known as a Certificate of Formation) for such Corporation:

ARTICLE I


