**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of One-hundred seventy-nine thousand nine-hundred (\$179,900.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Jacob Huffstutler and Christy Huffstutler, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto John Taylor Hawkins and Mary Prince Hawkins (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

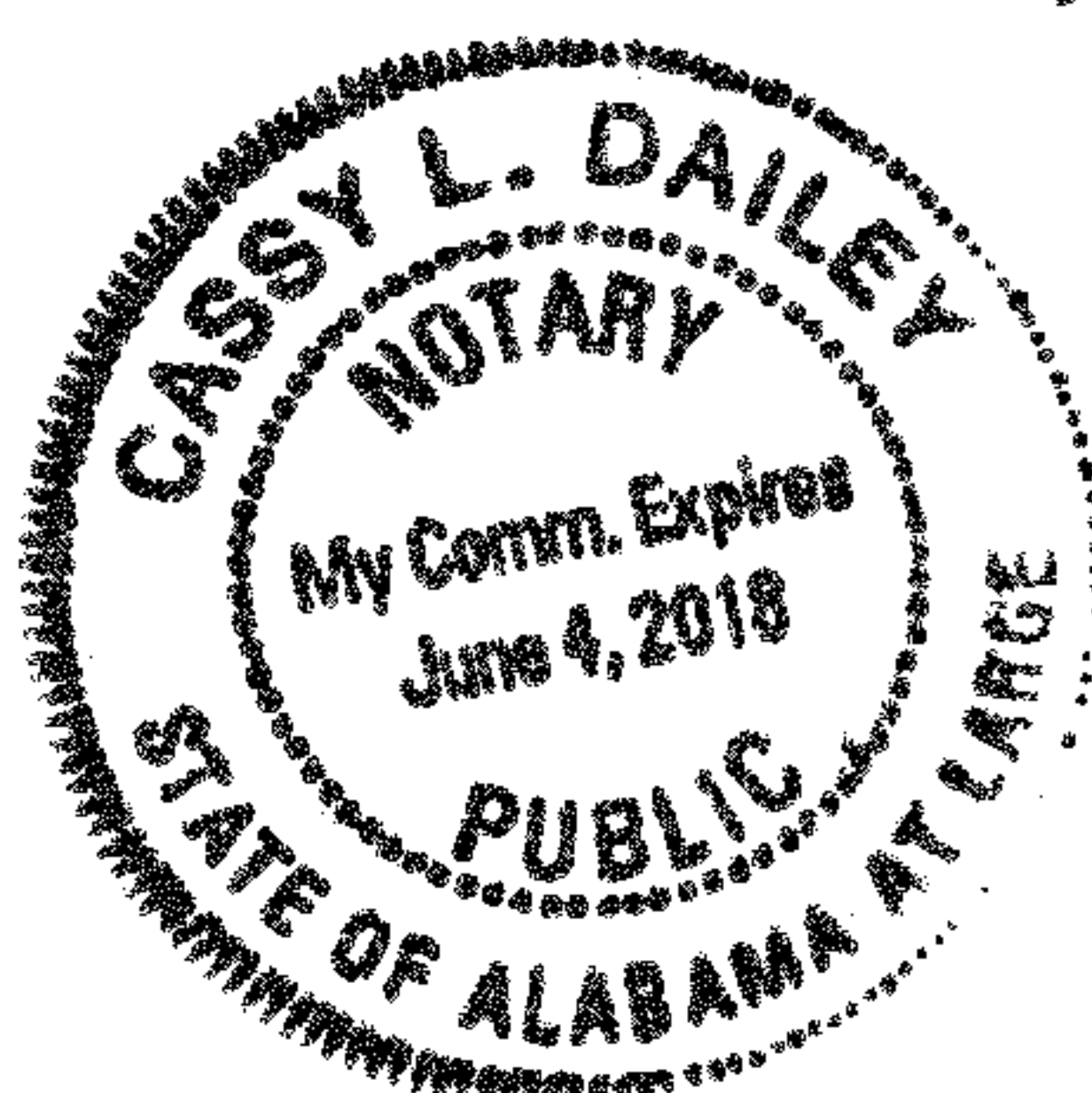




