**KNOW ALL MEN BY THESE PRESENTS**, That in consideration **EIGHTY THOUSAND AND NO/00 DOLLARS (\$80,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Christopher C. Smith, a married man (herein referred to as Grantor)** grant, bargain, sell and convey unto **Christopher C. Smith and Stacy L. Smith (herein referred to as Grantees)**, the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:
