**GENERAL WARRANTY DEED  
With Right of Survivorship**

STATE OF ALABAMA }

COUNTY OF Shelby } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Forty-Two Thousand Dollars and NO/100 (\$242,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **William Rickles White**, a married person conveying property that is not his homestead nor that of his spouse, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **William C Ewen and Betty J Ewen** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **Shelby** County, Alabama to wit:

**Lot 14, According to the Survey of Greystone Farms, Guilford Place, Phase 2, as recorded in Map Book 22, Page 24, in the Probate Office of Shelby County, Alabama.**

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

\$ 160,000.00 of the above consideration was secured by and through the purchase money mortgage closed herewith.

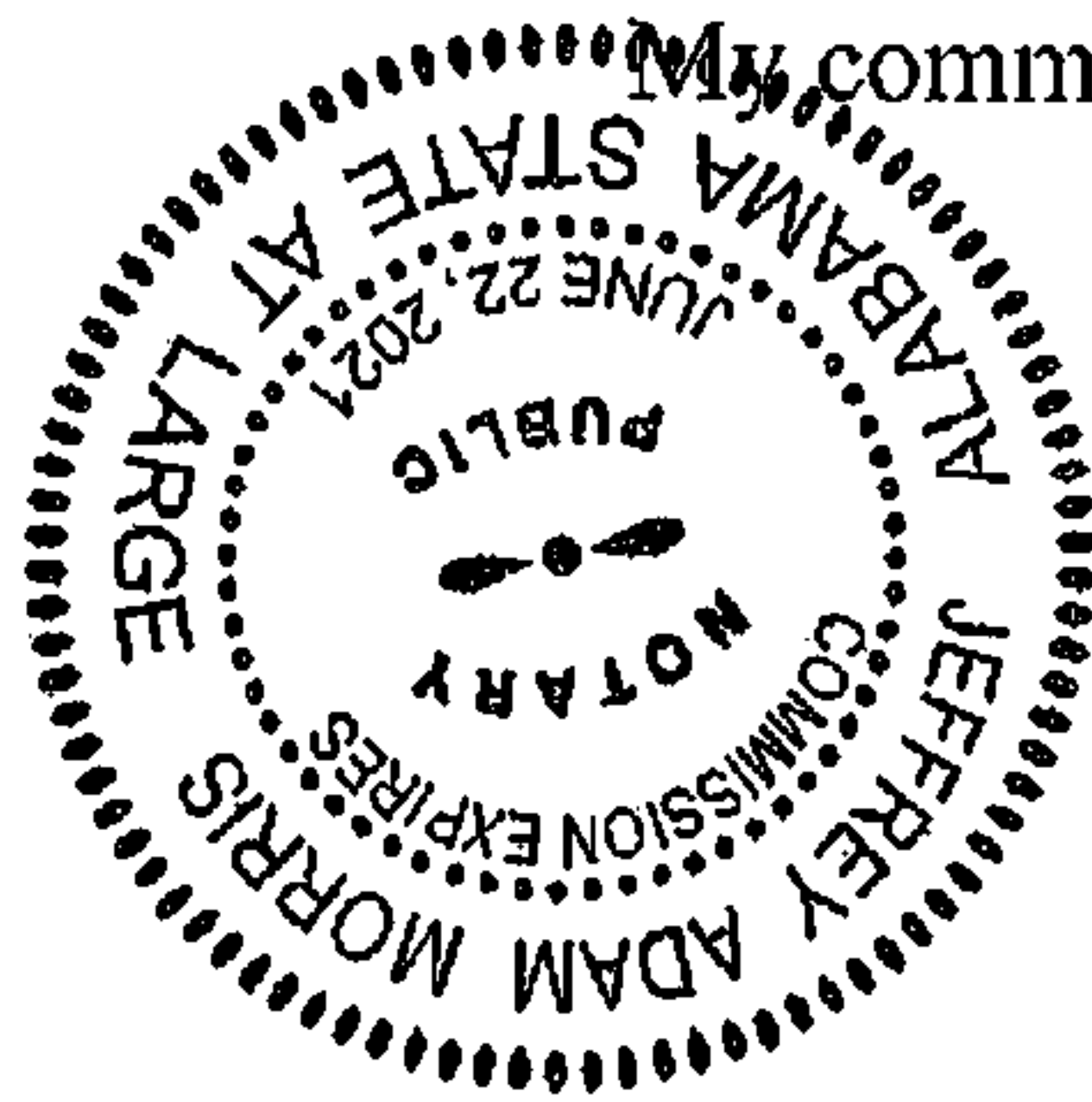
