Pursuant to Code of Alabama 1975, Sections 10A-1-3.15, 10A-1-3.17, 10A-5A-2.02 and 10A-5A-12.01, the undersigned hereby submit the following:

The Articles of Organization of the limited liability company were filed in the office of the Judge of Probate of Shelby County, Alabama on January 30, 1997 as the formation document (such Articles of Organization referred to herein as the "original Articles of Organization").

The Articles of Organization are hereby amended, superseded, and restated by this Restated Certificate of Formation and shall be as follows:

1. **Name.** The name of the limited liability company is Splawn & Ward Associates, LLC.

2. **Registered Agent and Registered Office.** The street address and mailing address of the registered office of the limited liability company and the name of the registered agent at said address shall be as follows:

3. **Members.** There is at least one member of the limited liability company.

THE ABOVE AND FOREGOING RESTATED CERTIFICATE OF FORMATION has been duly adopted this 1st day of JANUARY, 2017, in accordance with the Alabama Business and Nonprofit Entities Code (the "Code") and the governing documents of the limited liability company.

The amendments effected by this Restated Certificate of Formation are as follows:

A. Article II of the original Articles of Organization is replaced by Article 2 above above which reflects a change to provide the current registered agent and registered office address;

B. Article VII of the original Articles of Organization is replaced by Article 3 above, and the record should no longer reflect the names of the initial members listed in the original Articles of Organization.

C. Articles III, IV, V, VI, VIII, IX, X, XI, and XII of the original Articles of Organization are deleted.

This Restated Certificate of Formation accurately states the text of and does not contain any other change to the original Articles of Organization, except as described herein.

This Restated Certificate of Formation may be executed in any number of counterparts and all of such counterparts shall for all purposes constitute one instrument, notwithstanding that all parties are not signatories to the same counterpart, and further, the pages of the counterparts on which appear the signatures of the parties may be detached from the respective counterparts of the Certificate and attached all to one counterpart which shall represent the final instrument.
