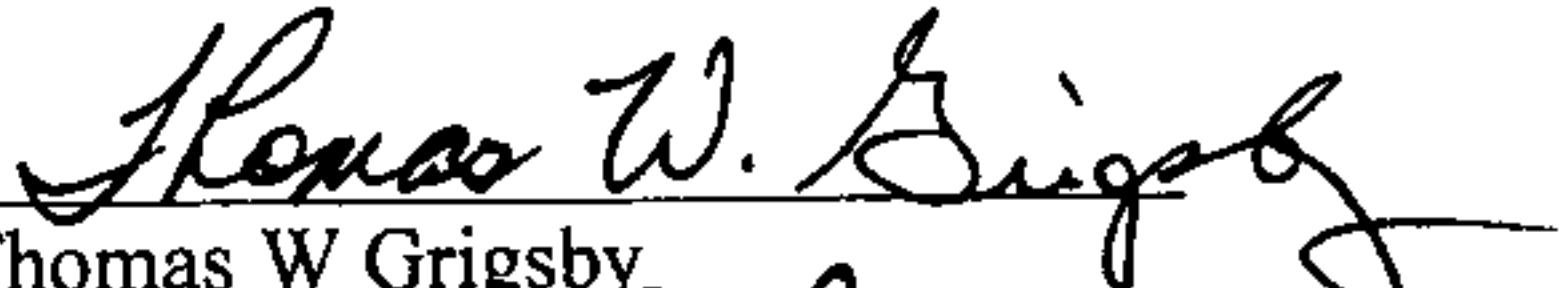
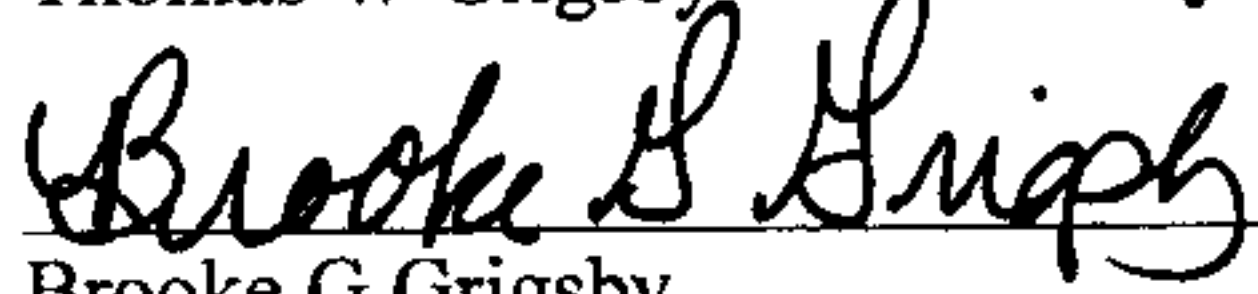

Be it known that \$290,702.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.

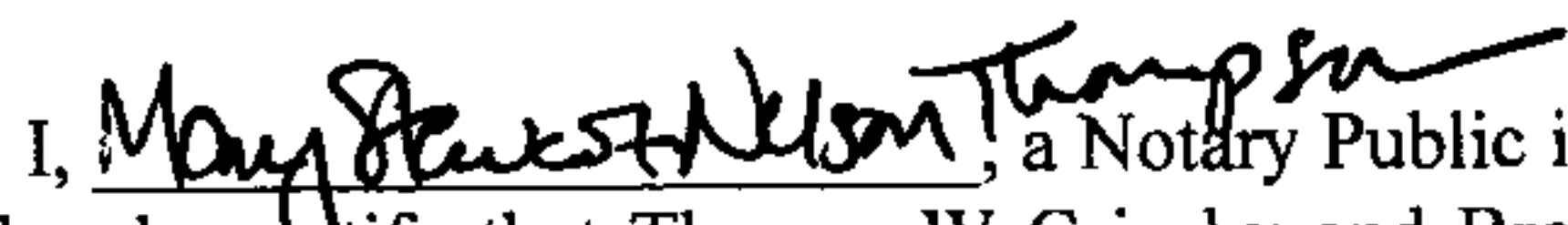

said grantees, his, her or their heirs and assigns forever, against the lawful claims of all persons.

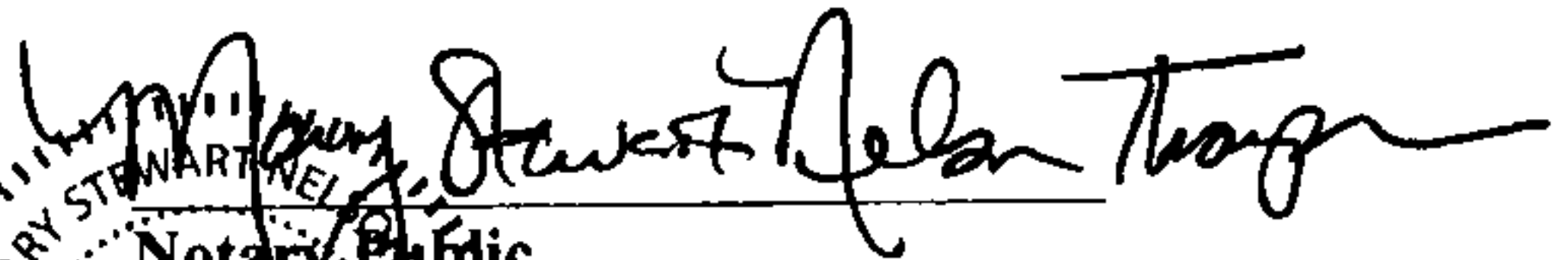
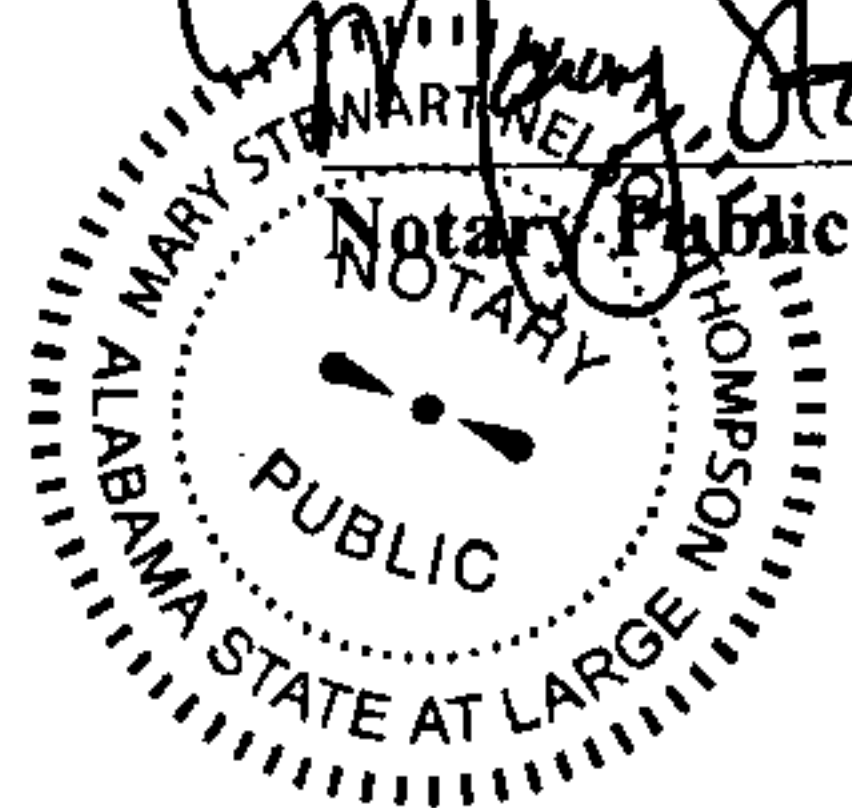
