WHEREAS, heretofore on, to-wit, June 4, 2010, Misty L. Green and Heath M. 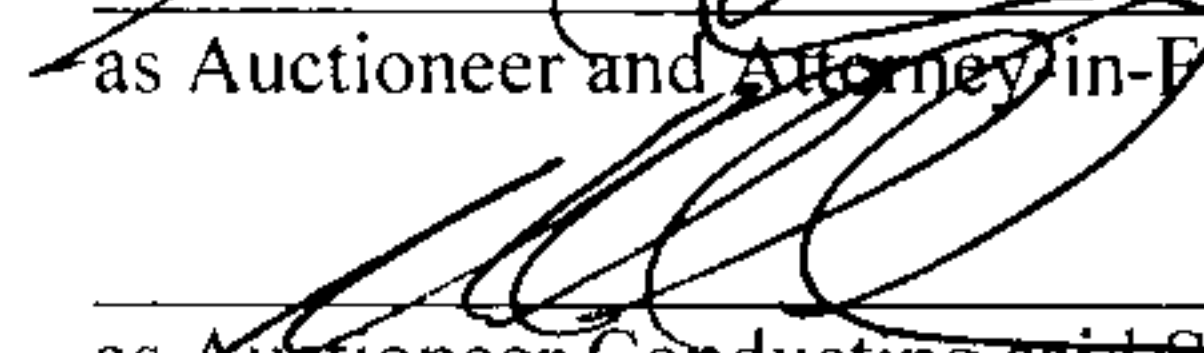

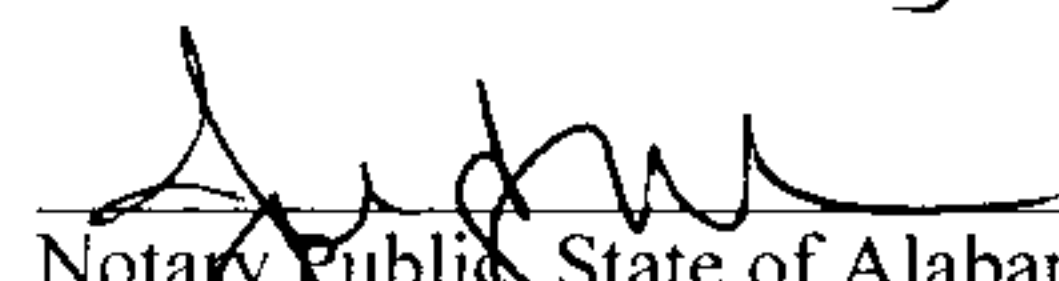
