The Association claims a lien upon property owned by Nidel Yousif, situated in Shelby County, Alabama described as follows:

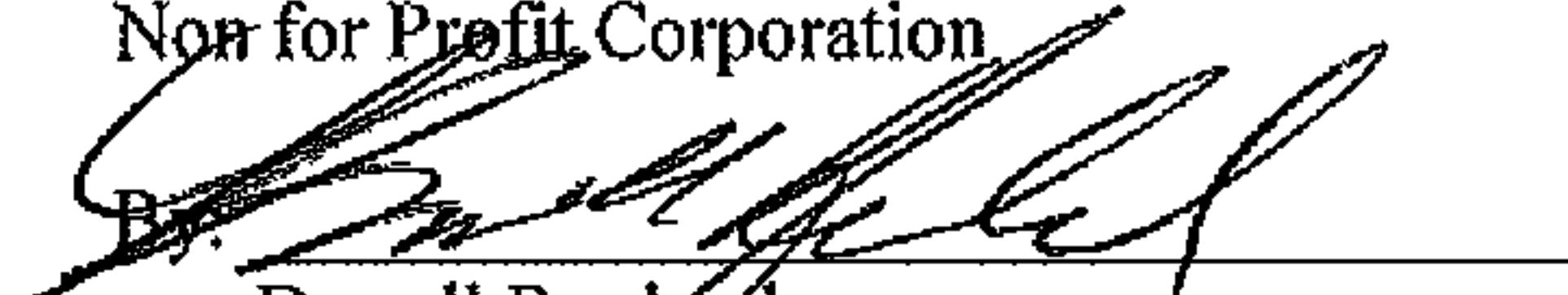
