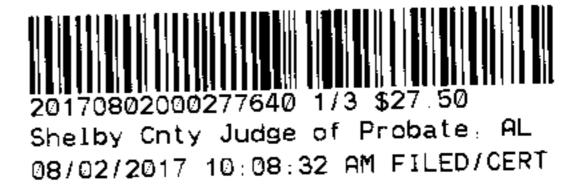

### KNOW ALL MEN BY THESE PRESENTS,

acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees,

during their joint lives and upon the death of either, then to the survivor of them in fee simple, together
with every contingent remainder and right of reversion, all of the Grantor's interest in the followingdescribed Real Estate situated in, SHELBY COUNTY, ALABAMA, to wit:
