IN TRUST, UNDER THE DELONG LIVING TRUST, DATED JULY 28, 2017, AND ANY  
AMENDMENTS THERETO**

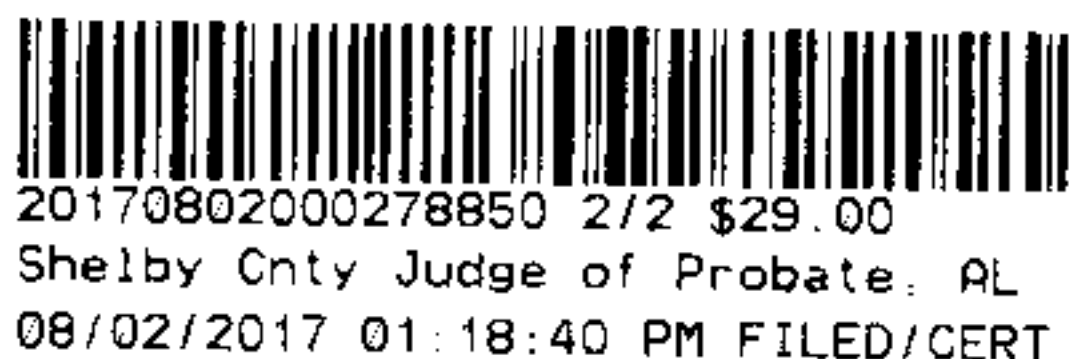
