WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Eighty Five Thousand and 00/100 Dollars (\$285,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Horye Glenn Flowers, II, and his wife, Nia J. Flowers

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Corbett Lovelady and Krista Lovelady

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 477, according to the Final Plat of Stoneykirk at Ballantrae, Phase 3, as recorded in Map Book 35, Page 11, in the Probate Office of Shelby County, Alabama.

\$270,750.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2017 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

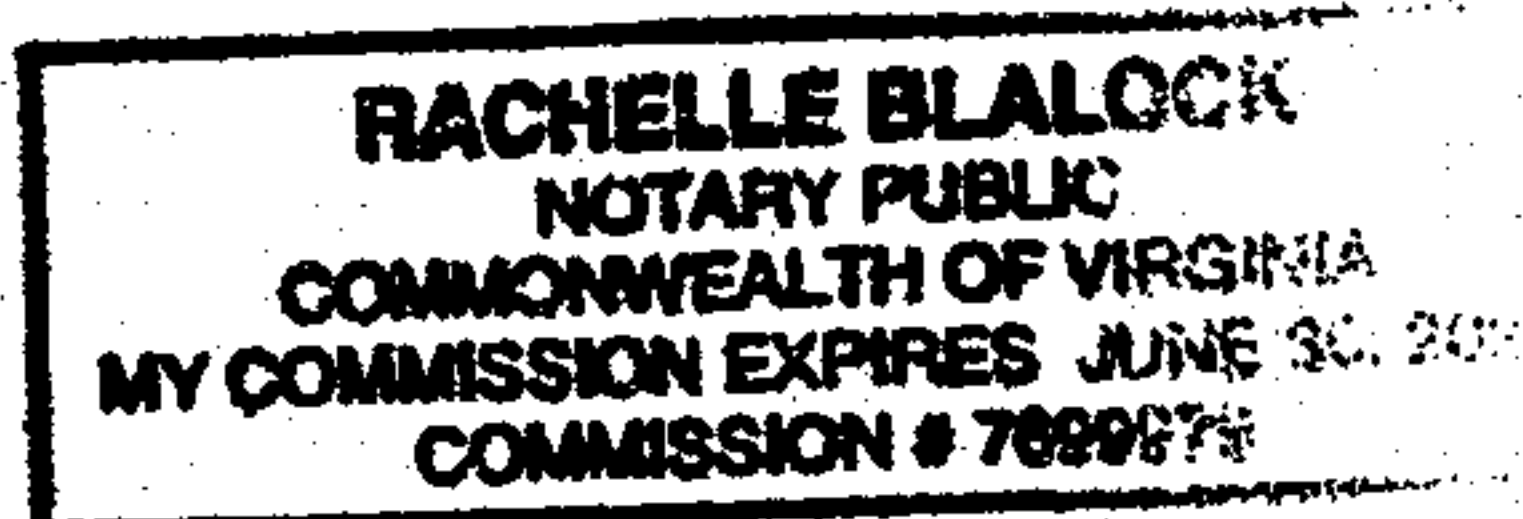
