**ARTICLES OF ORGANIZATION

The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act, hereby adopts the following Articles of Organization for F&F RENTALS, LLC:

ARTICLE ONE

The name of the Company is F&F RENTALS Limited Liability Company (LLC).

ARTICLE TWO

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The Company is organized for the purpose of owning, renting, and managing real estate.

ARTICLE FOUR

ARTICLE SEVEN

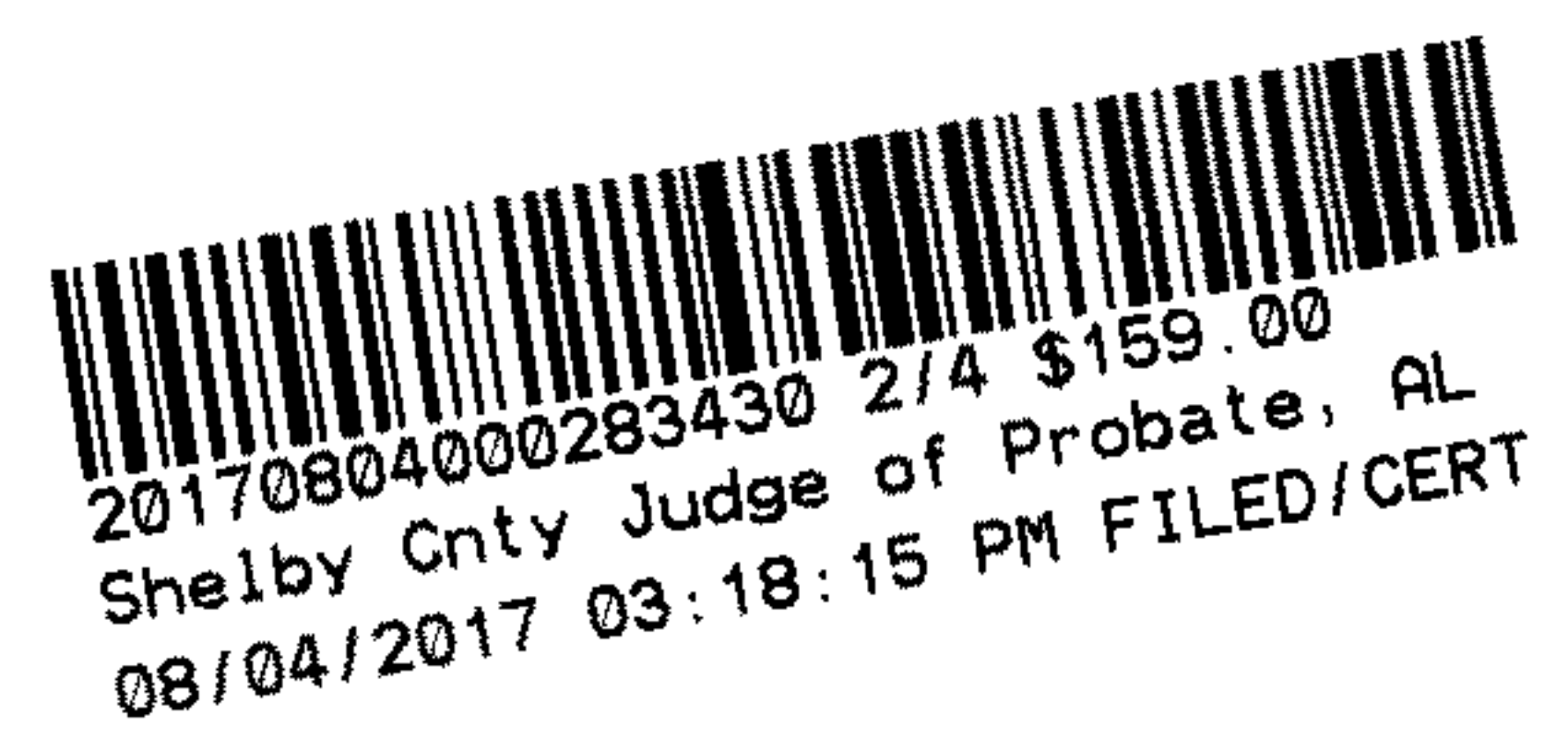
The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Limited Liability Company is continued by a written consent of all the remaining members within ninety (90) days after the occurrence of the events of disassociation.

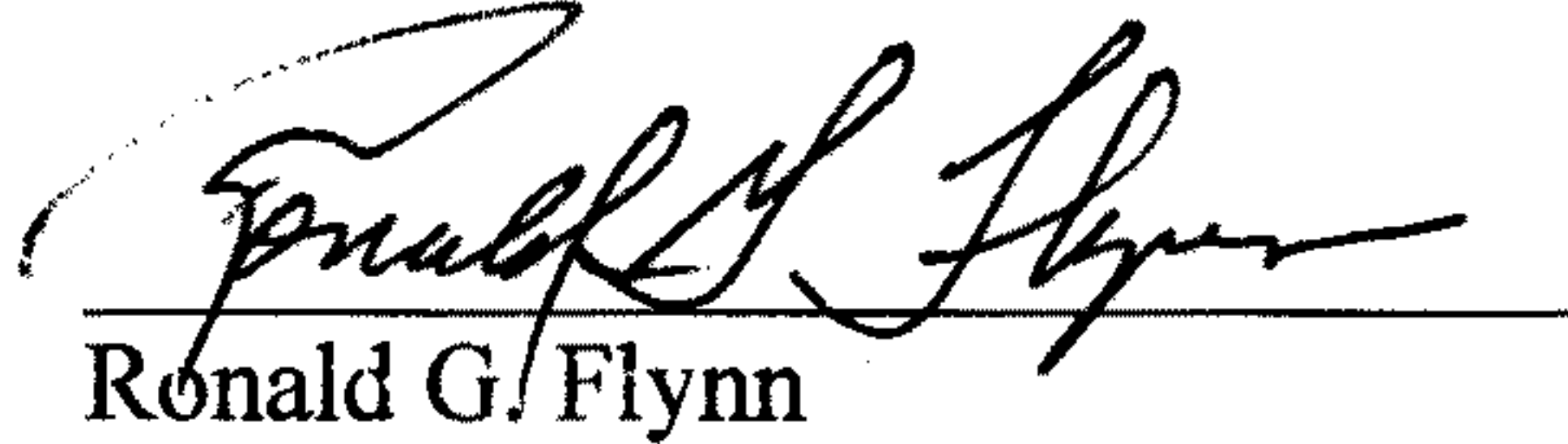

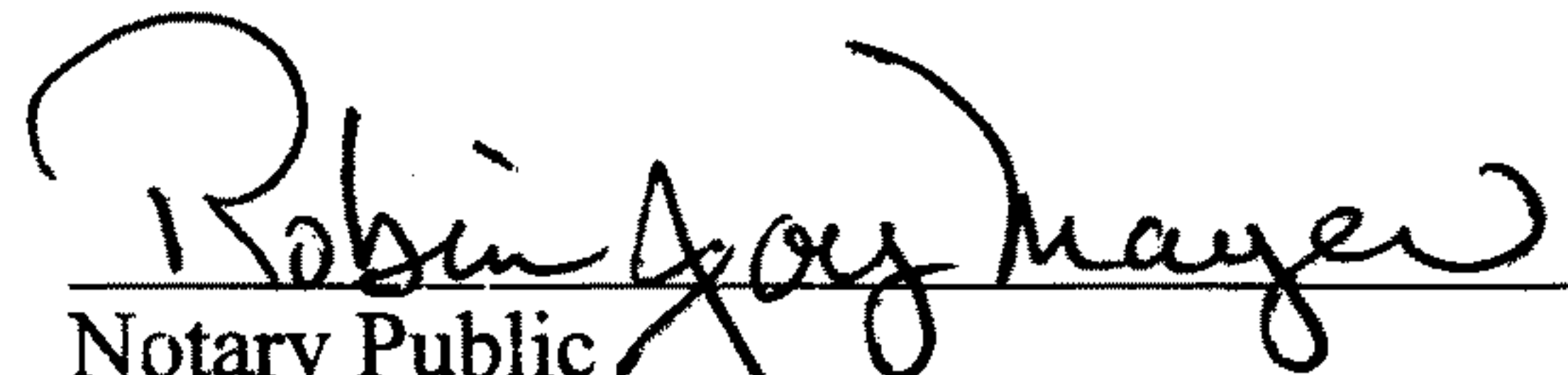

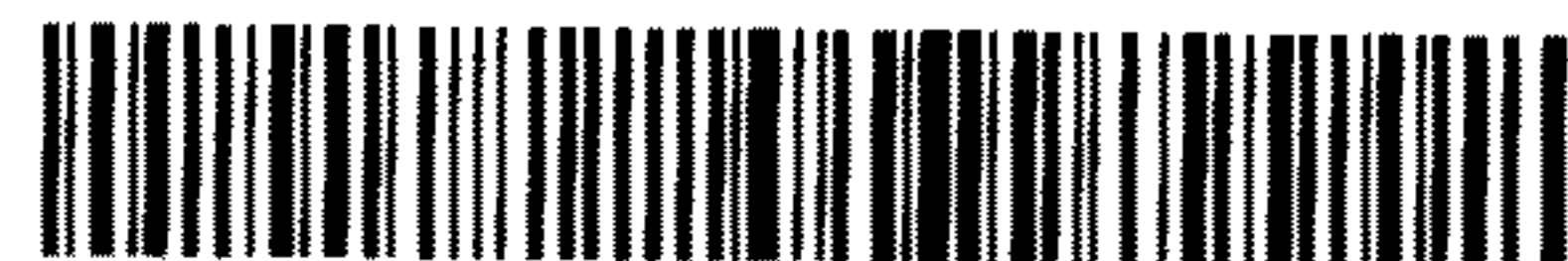
