**ARTICLES OF AMENDMENT
TO THE
CERTIFICATE OF FORMATION
OF

Pursuant to the provisions of Section 10A-5A-2.02 *et seq.* of the Code of Alabama 1975, as amended, the undersigned limited liability company adopts the following Articles of Amendment to its Certificate of Formation:

SECOND: The following amendments to the Articles of Organization were adopted by the Member of the Company on the 1st day of July, 2017, in the manner prescribed by the Alabama Limited Liability Company Law:

WHEREAS, all of the members of the Company desire to change the name of the Company from The Harvest Group, LLC to Draft Point, LLC; and

WHEREAS, all the members of the company desire to amend the stated purpose for with the Company is organized to reflect that the purpose of the Company is to develop and provide venue-oriented fantasy sports software; and

WHEREAS, all the members of the company desire to change the name of the initial registered agent for service of process of the Company from Steven E. Donohue to Benjamin J. Donohue.

NOW, THEREFORE, BE IT RESOLVED, by all of the members of the Company, pursuant to the requirements of Section 10A-5A-2.02 *et seq.*, Code of Alabama 1975, that the name of the Company be changed from The Harvest Group, LLC to Draft Point, LLC; and,

RESOLVED FURTHER, that the first article of the Certificate of Formation of the Company be amended to read as follows:

ARTICLE I

The name of the limited liability company is Draft Point, LLC (the "Company").

RESOLVED FURTHER, by all of the members of the Company, that the stated purpose for which the Company is organized be changed from, *inter alia*, consulting with financial services providers and others regarding client attraction and retention, to, *inter alia*, developing and providing venue-oriented fantasy sports software; and

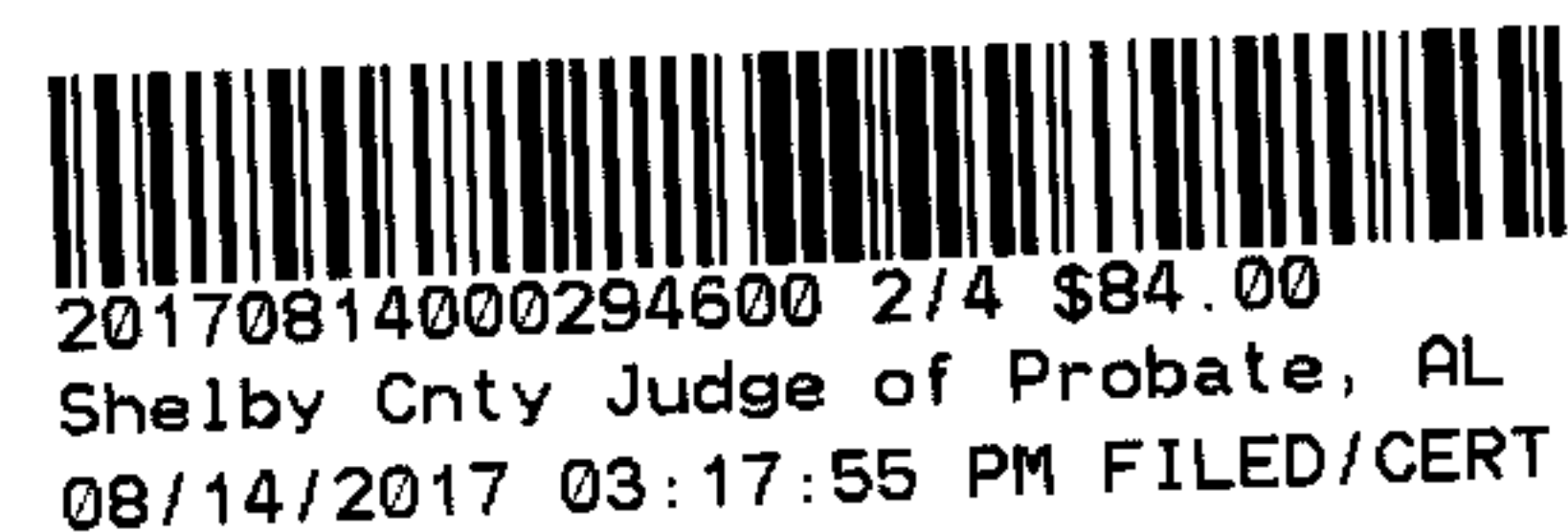
RESOLVED FURTHER, that subsection (a) of the third article of the Certificate of Formation of the Company be amended to read as follows:

ARTICLE III

(a) To engage in the business of and to engage in all activities, render all services, and handle and deal in all materials, supplies and products incidental or related to or connected with the business of developing and providing venue-oriented fantasy sports software.

RESOLVED FURTHER, by all of the members of the Company, that the name of the initial registered agent for service of process for the Company shall be changed from Steven E. Donohue to Benjamin J. Donohue; and

RESOLVED FURTHER, that the fourth article of the Certificate of Formation of the Company be amended to read as follows:



ARTICLE IV

The location and mailing address of the initial registered office of the company shall be 4017 Grove Park Circle, Birmingham, Alabama 35242. The initial registered agent for service of process at the foregoing address shall be Benjamin J. Donohue.

RESOLVED FURTHER, that that the members of the Company hereby authorize Steven E. Donohue, as the sole member and manager, to execute any and all documents on behalf of the Company which are necessary or convenient to effectuate the foregoing resolutions.
