**GENERAL WARRANTY DEED  
With Right of Survivorship**

STATE OF ALABAMA }

COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Sixty-Two Thousand Dollars and NO/100 (\$262,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Kevin M. Hayes, a married person conveying property that is not his homestead nor that of his spouse,** (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Stephen L. Moody and Erin N. Moody** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

**Lot 78, according to the Final Plat of Oaklyn Hills, Phase 2, as recorded in Map Book 30, Page 17, in the Probate Office of Shelby County, Alabama.**

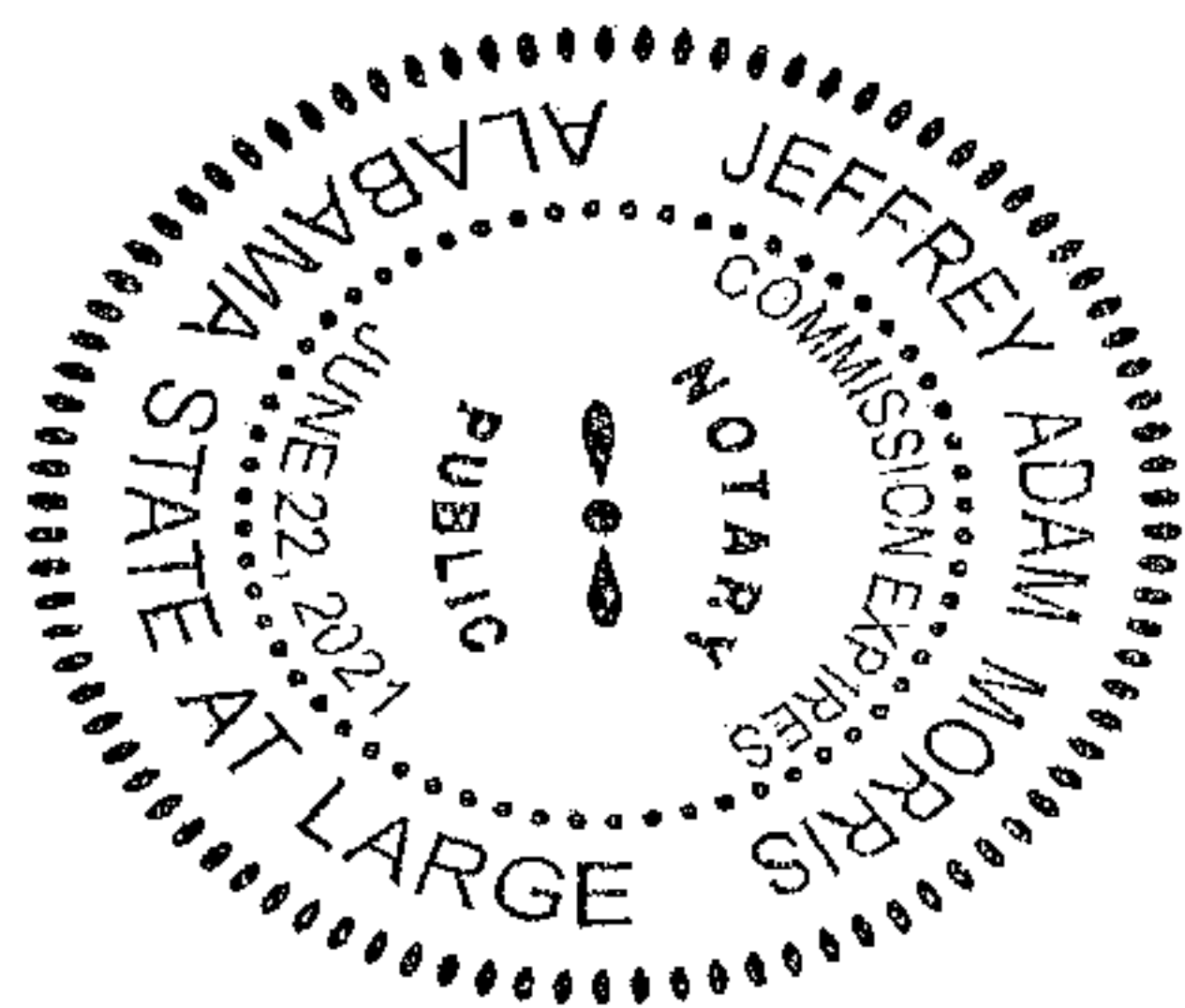
