Lot 57, as recorded in Map Book 29, Page 136, Shelby County, Alabama records

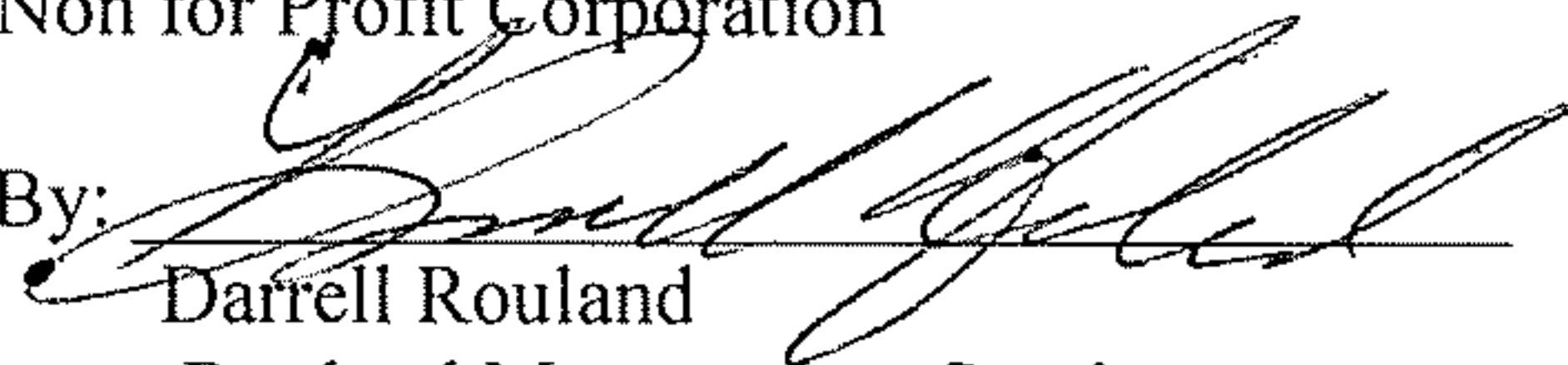

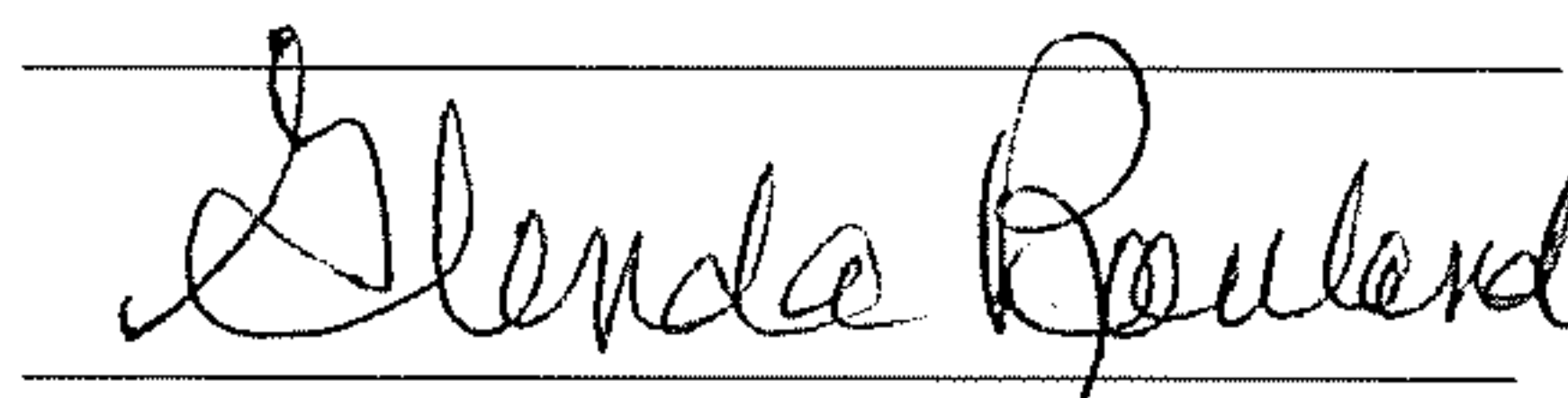
