NAME

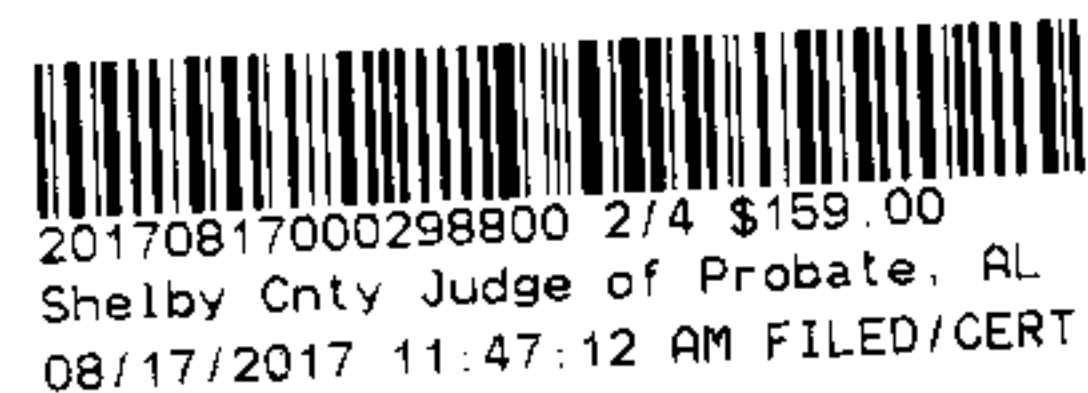
The name of the limited liability company (the "Company") is: VICENTE'S AUTOMOTIVE PAINT & BODY, LLC.

ORGANIZER**

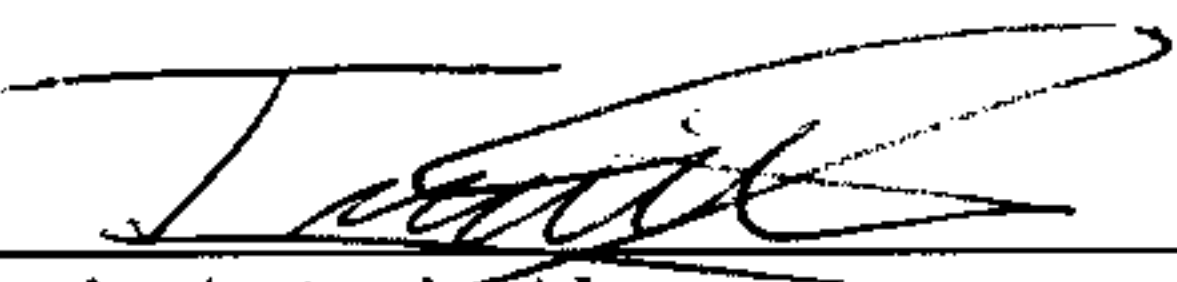

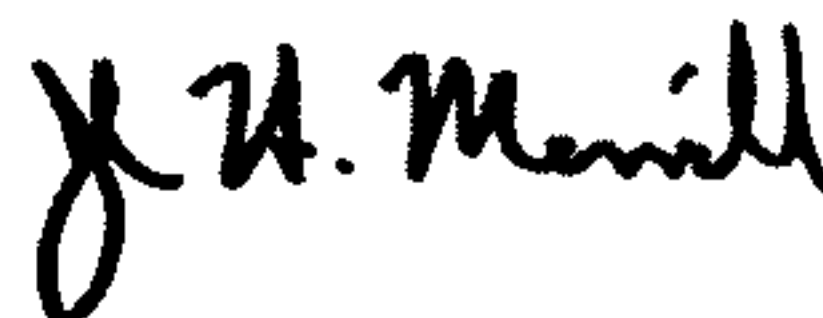
