The Association claims a lien upon property owned by **Charles Andrew Daily** situated in Shelby County, Alabama described as follows:

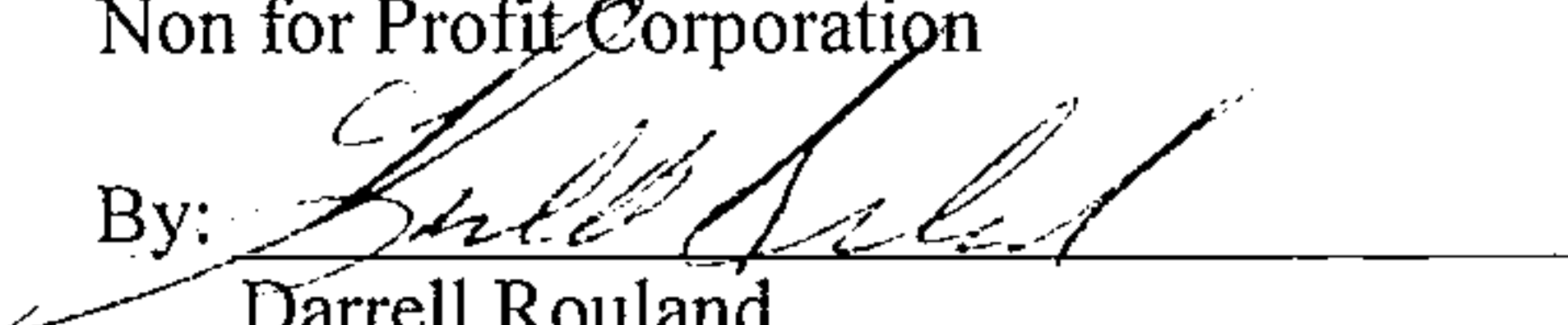

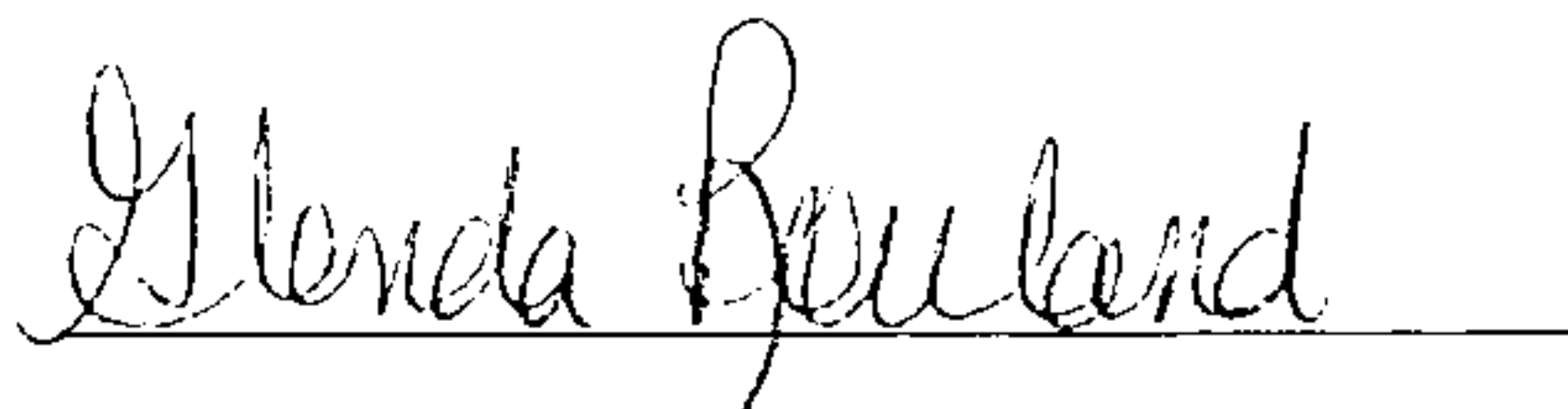
