The undersigned, being a natural person of at least 19 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Alabama Limited Liability Company Law of 2014, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:


