Pursuant to Section 10A-5A-2.01, Code of Alabama (1975) *et seq.*, the undersigned hereby adopts the following Limited Liability Company's Certificate of Formation:

ARTICLE I – NAME

The Name of the Limited Liability Company shall be **No-Weld Solutions, LLC** (the "Company").

ARTICLE II – DURATION

The period of duration of the Company shall be perpetual, unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III – PURPOSES

The Company has been organized to engage in the business of telecom tower component design and innovation, related services, and any other lawful business the members shall reasonably decide to pursue. The Company shall have all powers permitted by the Act, as amended from time to time.


ARTICLE VII – SERIES COMPANIES

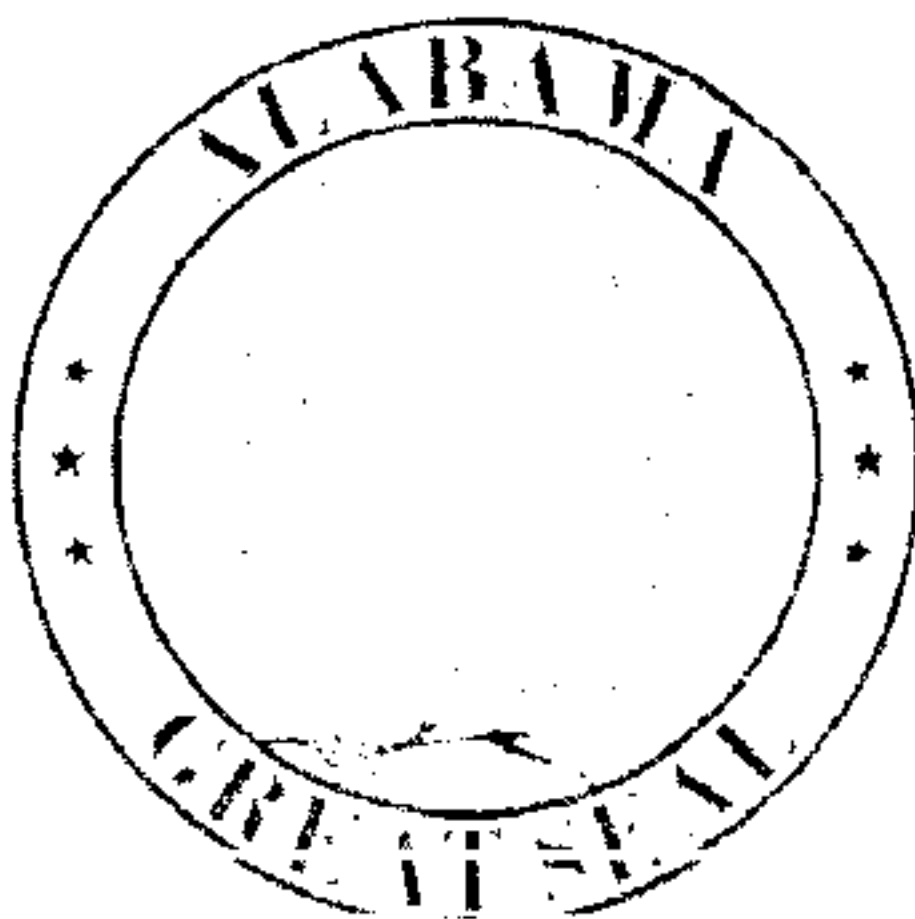
