**ARTICLES OF ORGANIZATION
OF
ELITE SOUTH, LLC**

The undersigned, being the members of Elite South, LLC, a limited liability company formed pursuant to Section 10A-5A-1.01 et seq. of the Alabama Code, adopt the following Articles of Organization for such company:

ARTICLE 1:

The name of the Limited Liability Company is Elite South, LLC.

ARTICLE 2:

The term of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall have a perpetual duration; provided, however, that the Limited Liability Company shall be dissolved: (a) upon the written consent of the holders of the portion of the ownership interest of the company specified in the Operating Agreement, as amended from time to time; (b) as provided in the Operating Agreement, as amended from time to time; or (c) as may be required by the Alabama Limited Liability Company Act, as amended from time to time.

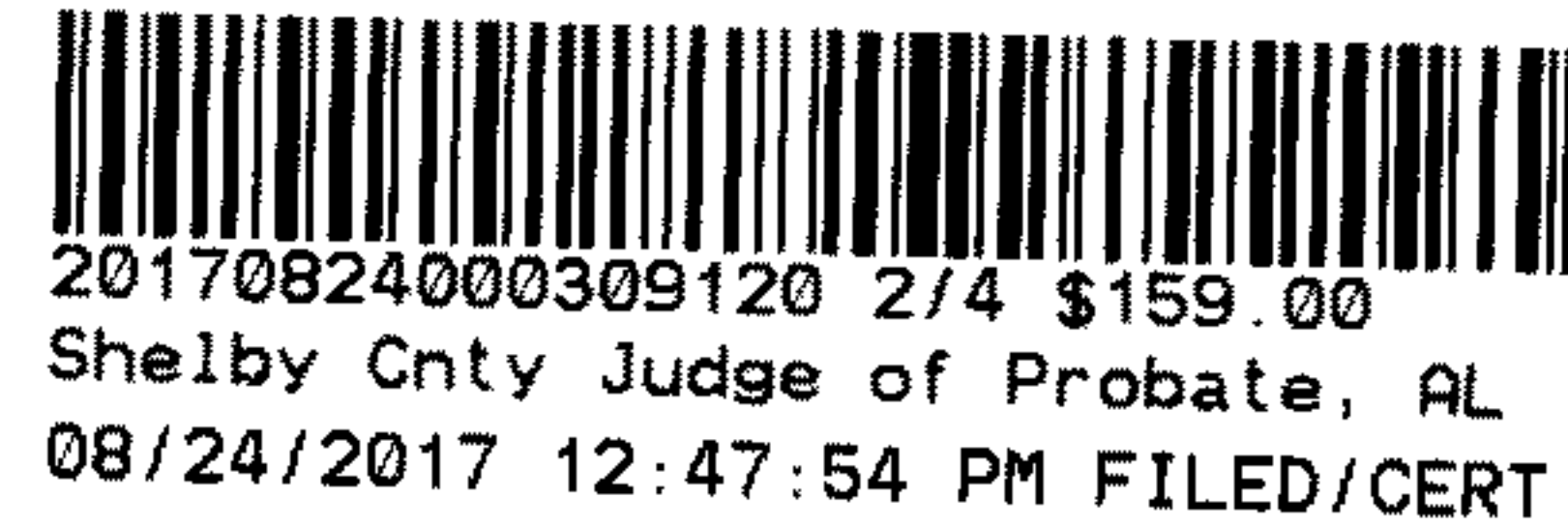
ARTICLE III:
