

## **QUITCLAIM DEED**



## STATE OF ALABAMA COUNTY OF SHELBY

KNOW ALL PERSONS BY THESE PRESENTS, that in consideration of ten dollars (\$10.00) and other good and valuable consideration in hand paid to Wells Fargo Bank, N.A., as Successor Trustee of the Annie J.
