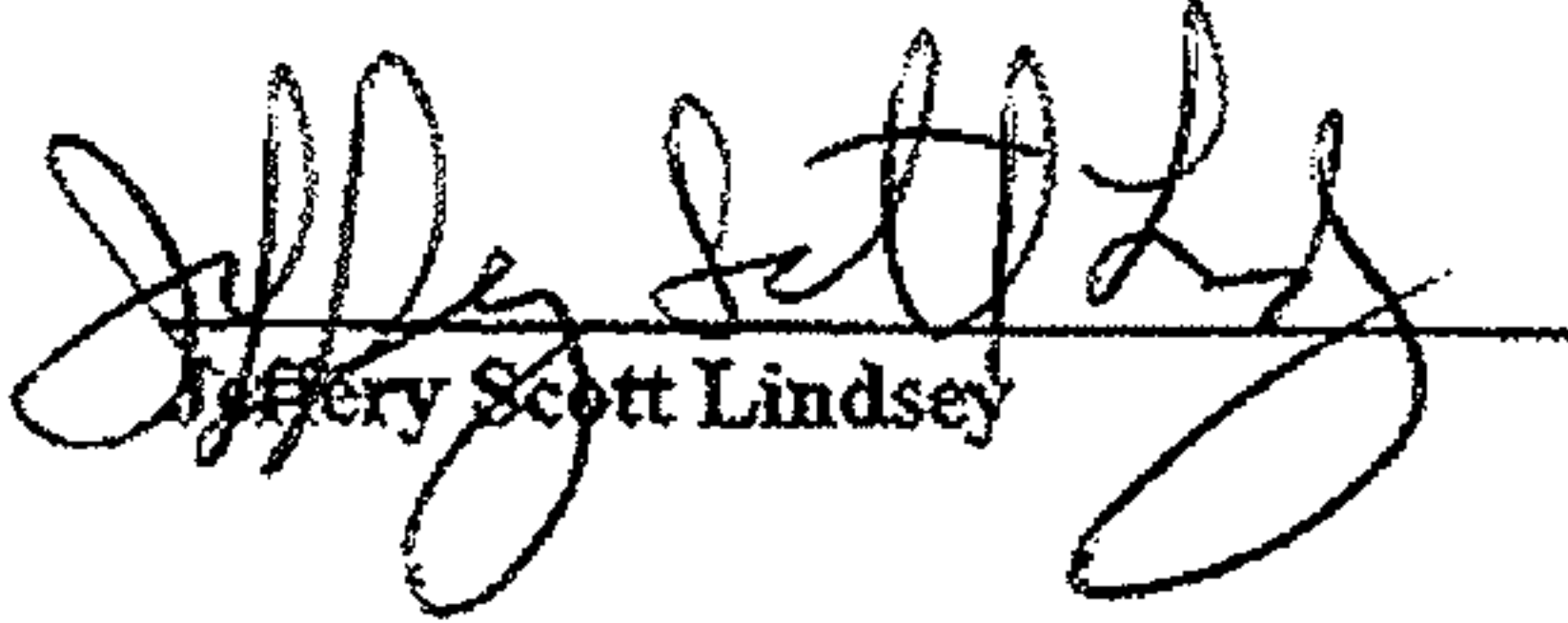

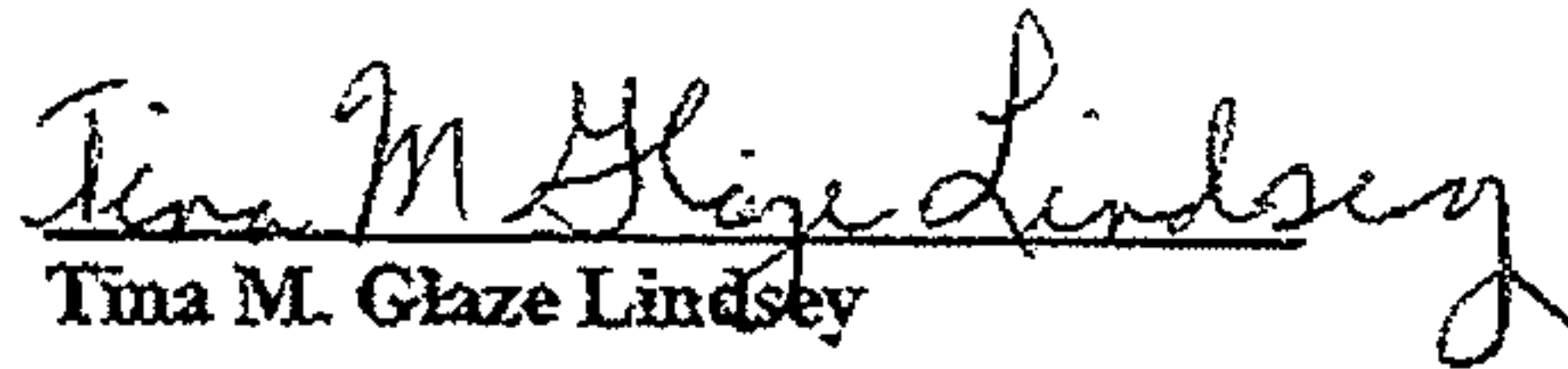
The undersigned Trustees hereby certify the following:

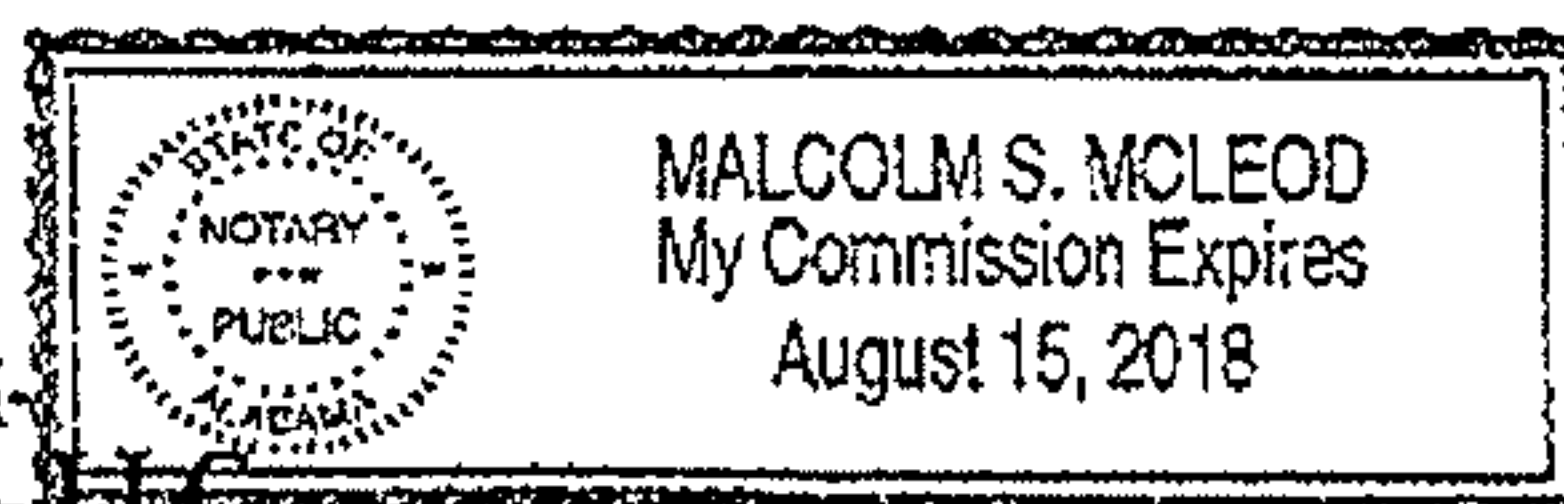

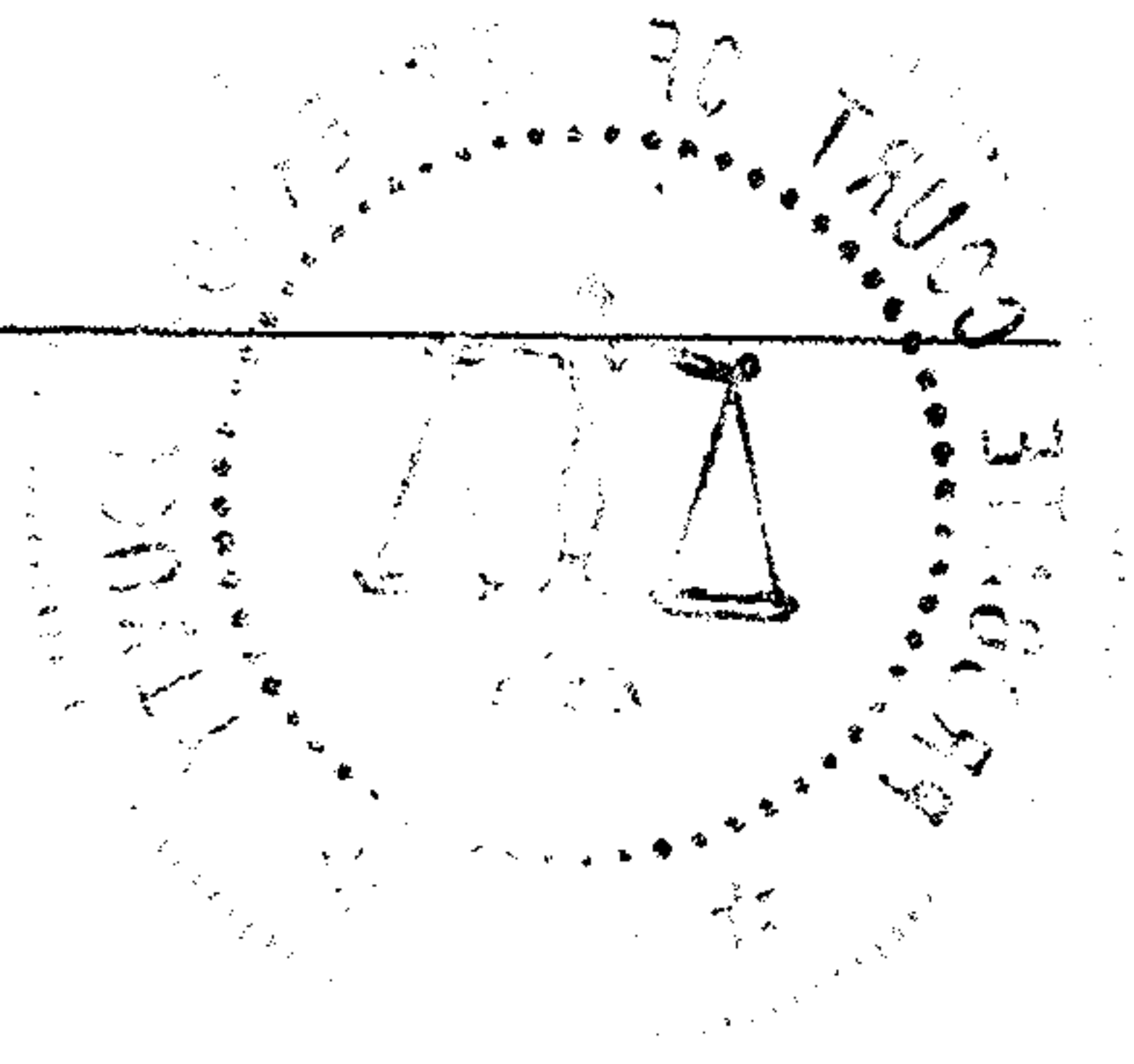

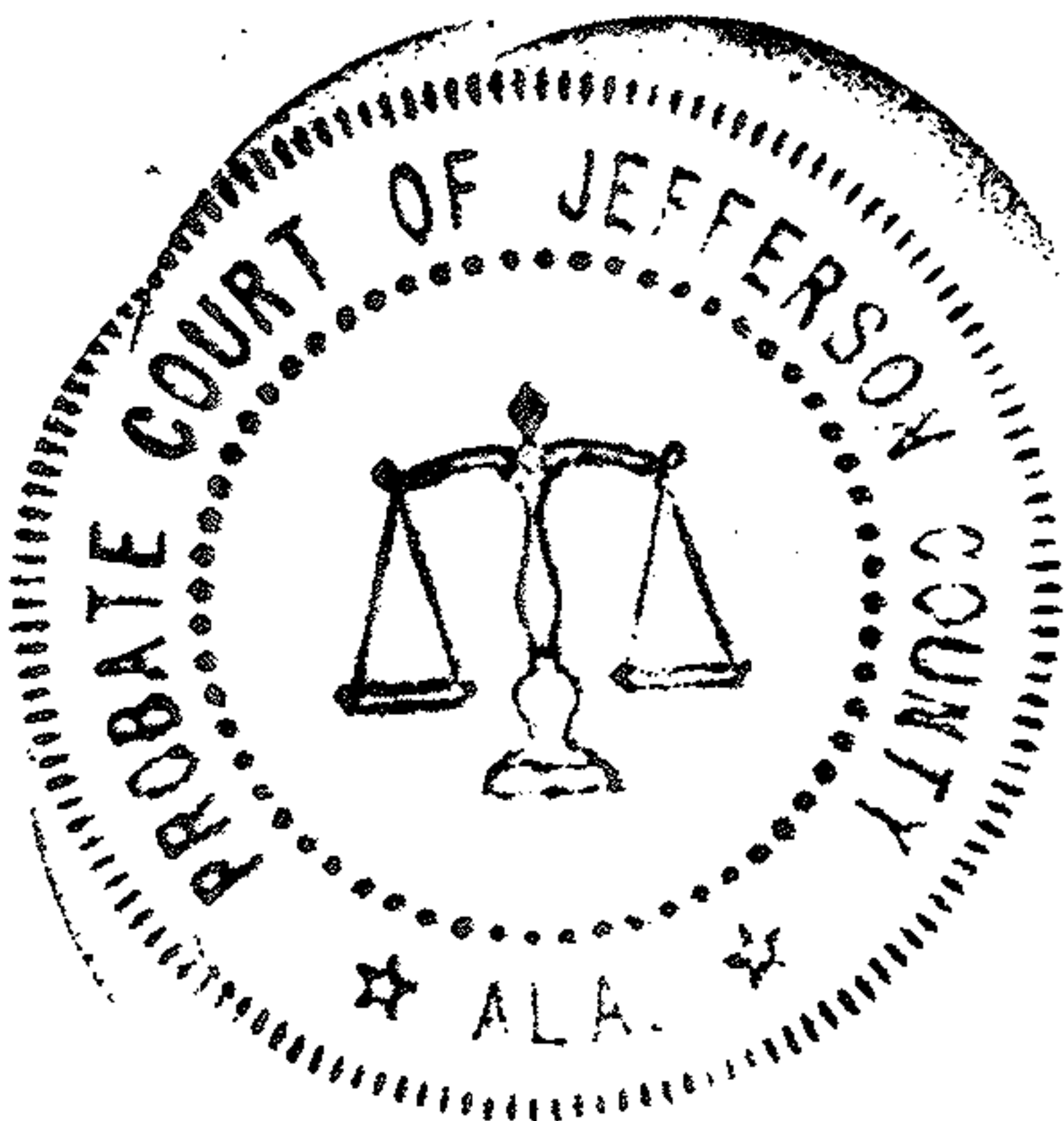
